RESOLUTION NO. 2025-27

A RESOLUTION OF THE VILLAGE COUNCIL OF MIAMI SHORES VILLAGE FLORIDA; AUTHORIZING THE VILLAGE MANAGER OR DESIGNEE TO ISSUE A PURCHASE ORDER TO RECHTIEN INTERNATIONAL TRUCKS, INC. FOR THE PURCHASE OF A 2025 ALTEC AT41M BUCKET TRUCK, IN THE AMOUNT NOT TO EXCEED \$222,579, UTILIZING THE TERMS AND CONDITIONS OF THE FLORIDA SHERIFF'S ASSOCIATION COOPERATIVE PURCHASING PROGRAM BID FSA23-VEH21.0 ("ITB"); APPROVING BUDGET AMENDMENT NO. 5 TO THE FISCAL YEAR 2024-2025 CAPITAL BUDGET; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE THE PIGGYBACK AGREEMENT; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, articulating telescopic aerial bucket trucks are an essential piece of equipment for Public Works Departments because it allows staff to safely and efficiently perform elevated tasks that would otherwise be difficult or hazardous; and

WHEREAS, The Public Works Department relies on a bucket truck equipment for tasks such as servicing signage, working on poles, and tree trimming.; and

WHEREAS, one of these vehicles, a 2007 Altec Bucket Truck, has been in use for 18 years and has now reached the end of its service life and is currently inoperable; and

WHEREAS, the Village identifies contracts competitively solicited and awarded by other governmental agencies as a favorable procurement method; and

WHEREAS, Section 5 of Resolution No. 1124-07 allows for the use of other governmental entities' contracts upon a determination that the supplies, materials, equipment or contractual services needed by the Village were purchased using solicitation procedures which are substantially equivalent to the Village's Purchasing Guidelines; and

WHEREAS, the Florida Sheriff's Association Cooperative Purchasing Program, a service cooperative created to leverage the buying power of local government agencies, issued Invitation to Bid # FSA23-VEH21.0 ("ITB") and awarded

the ITB in the Southern District to Rechtien International Trucks, Inc. ("RECHTIEN"); and

WHEREAS, the Village is seeking the same equipment and pricing set forth in #FSA23-VEH21.0 and believes it is in the best interests of the Village to purchase the bucket truck utilizing the Florida Sheriff's Association Cooperative Purchasing Program contract, which was competitively bid and negotiated for the same equipment and pricing with Rechtien International Trucks, Inc.; and

WHEREAS, the Village Manger and the Public Works Director recommend that the Village Council approve the purchase utilizing the Florida Sheriff's Association Cooperative Purchasing Program; (ITB # FSA23-VEH21.0), in an amount not to exceed \$222,579, and

WHEREAS, The Village's Local Option Gas Tax Fund ("LOGT") can be used to fund transportation-related projects and expenses; and

WHEREAS, the cost for replacement of the bucket truck is an unbudgeted item with funds available in the LOGT Fund Balance; and

WHEREAS, budget Amendment No. 5 will transfer these dollars from the Local Option Gas Tax Fund Balance account 130-281100 to the LOGT expenditure line item, account GL130.39.1222.00.541_64-100. for the replacement of the bucket truck; and

WHEREAS, the Mayor and Village Council believe it is in the best interests of the Village to authorize the Village Manager or designee to issue a purchase order for the purchase of an Altec AT41M Bucket Truck from Rechtien International Trucks, Inc., in an amount not to exceed \$222,579; and amend Village's Local Option Gas Tax Fund expenditure line item to complete the purchase.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF MIAMI SHORES VILLAGE, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That the above stated recitals are hereby adopted and confirmed.

Section 2. <u>Authorization to Execute Agreement.</u> The Village Council hereby authorizes the Village Manager or designee issue a purchase order in an amount of \$222,579 to Rechtien International Trucks, Inc. for the purchase of the

Altec AT41M Bucket Truck.

Section 3. <u>Budget Amendment #3.</u> This Resolution creates Budget Amendment No.5 to the FY 24-25 Operating Budget increasing the Local Option Gas expenditure line item, account GL130.39.1222.00.541_64-100 and the Revenue Reserve line item 130-389-900 by \$222,579.

Section 4. Effective Date. That this Resolution shall take effect immediately upon the adoption hereof.
