# **REGULAR MEETING BUSINESS:**

Beach Tag Awards

Sandman Consolidated School; the seasonal beach tag design winner is Shaye Fletcher, an 8th grade student from Richard M. Teitelman School; and the weekly design winner is Maya Eppenbach, a 5th grade student from Cape May Elementary School. The winners each spoke about why they chose to create their design and each winner received a gift certificate from the City of Cape May.

# 2016 Washington Street Mall Business Improvement District Budget presentation

Mr. MacLeod advises that the City will receive bids on the SCADA System upgrades project on Friday, November 20, 2015. The award of contracts for all of the aforementioned projects will take place on December 1, 2015. Mr. MacLeod announces that pre-season beach tags will go on sale on December 1, 2015 and the cost is \$20.00. Mr. Macleod reports that City is currently collecting leaves in the City of Cape May.

Mr. MacLeod gives a report on the staffing recommendations submitted by the Fire Department Committee.

Mayor Mahaney advises that Army Corps of Engineers and NJ DEP are highly involved with the beach project feasibility study and safety on the beaches of Cape May.

Patricia Hendricks, 106 Trenton Avenue, Cape May, talks about improving the live stream system and asks Council to include all the City Board/Committee meetings on live stream. Also, Ms Hendricks asks about "paperless" Council Meetings and is advised by Mr. MacLeod that the City has purchased tablets for Council to use, so meeting information can be forwarded electronically, eliminating photocopying, time and expense.

John Lindeman, 261 Grant Street, Cape May talks about beach replenishment and the beach slope feasibility study. Also, Mr. Lindeman asks about the new fencing on the beach at the Cove and why it was put up.

Mr. MacLeod advises that the snow fence was recently put up to prevent sand from blowing onto the street.

Beverly Yanich, 1015 New Jersey Avenue, Cape May asks about the updated salary ordinance and ask about employee performance reviews.

Mr. MacLeod comments that employee performance reviews will be performed by Department Heads.
