CITY MANAGER ITEMS

Mr. MacLeod reports that to date, the Occupancy Tax collection has increased \$33,199.00 over the same time period last year. Mr. MacLeod announces that there will be fewer lifeguards protecting the beaches and asks the public to swim at beaches that are protected. Mr. MacLeod announces the events schedule through the end of the summer season.

- Councilmembers Deputy Mayor Wichterman announces that the Cape Harmonaires will be appearing at the Rotary Bandstand on Wednesday, August 20, 2014 at 8:00 P.M. the concert is free.

Mayor Mahaney thanks the local residents and visitors for their support of the Summer Concert Series which concluded last night. The Concerts were a great success this summer, comments

the Mayor. Finally, Mayor Mahaney announces that the Philadelphia Boys Choir & Chorale will be in town for their third appearance, this Saturday night, August 23, 2014 at Convention Hall.

<u>PUBLIC PORTION</u>: Those wishing to publicly comment shall come forward, give their name and address and speak into the microphone. Each speaker will be limited to five (5) minutes.

Anita Desatnick, 1307 Trenton Avenue, Cape May questions the amount of money spent by the City to date on the school funding formula matter and asks what the average Cape May taxpayer would save on their yearly bill if the formula is changed.

Deputy Mayor Wichterman advises that \$48,000.00 has been spent on the feasibility study, and \$22,000.00 was spent for legal fees. Mr. Wichterman advises that \$75,000.00 has been placed in the City Budget for the year 2014 to be used, if needed, for the School Funding matter. Mr. Wichterman advises Mr. DeSatnick that the average taxpayer in the City of Cape May would save \$179.00 per million dollars and the average tax payer in Lower Township would pay \$85.00 per million dollars. Ms. DeSatnick and Mr. Wichterman both agree that they are happy to pay for education.

Jo Tolley, 404 W. Perry Street, Cape May, feels that changing the school funding formula will adversely affect the poor families living in Lower Township and comments that Cape May taxpayers can well afford to pay. Most of the homes in the City of Cape May are second homes, advises Ms. Tolley. She states that education gives children the opportunity to move forward in the future.

Susan Tishler, 507 Washington Street Mall, Cape May asks if the planned improvements for Lyle Lane include plans for Rotary Park.

Mayor Mahaney advises that a plan for Lyle Lane and Rotary Park will be introduced during a future phase for improvements in the year 2016.

Shaine Meier, 1217 Vermont Avenue, Cape May is in favor of quality education for the children. Mr. Meier asks if the school funding question can be put on the ballot at the General Election and why Cape May is responsible for the cost.

Deputy Mayor Wichterman replies that the New Jersey State statute does not allow the question to be placed on the ballot at a General Election.

City Attorney, Anthony Monzo, advises that the State statute is not clear on who is responsible to pay for the cost of the Special Election. Based on the decision of the Department of Education, Board of Review, the question will go forward at a Special Election and if there is no consensus between the participating municipalities as to who will pay, the County will have the Superior Court make a decision.

Mr. Meier questions the finalization plans for the Lafayette Street Park.

Mayor Mahaney replies that the plans are conceptual for the park and have not been finalized as of yet. The Mayor advises that the Residents will be involved in the process.

Dennis Desatnick, 1307 Trenton Avenue, Cape May, compliments Council on the beautification of the City. Mr. Desatnick disagrees with changing the school funding formula.

City Manager, Bruce MacLeod explains how the school funding formula is calculated.

Councilmember Murray reports that the referendum will give the City an understanding as to whether or not the voters are behind the formula change.

Julius Rauch, 1010 New York Avenue, Cape May is in favor of the School Funding Formula change and thanks Deputy Mayor Wichterman for his time and effort in the matter. Mr. Rauch feels that the City should have more than one representative on the School Board.
