ENGINEER REPORT

City Engineer, Ray Roberts, presents his engineer report as follows:

USDA Water Tank and Standpipe Expanded Improvements – A bid was awarded on October 21, 2014 for the repaving of sidewalks around the water tank. The bids for the rehabilitation of the lime silo and emergency generator wells #5 and #7 were awarded on November 3, 2014.

FY2014 Road and Utility Improvement Program – The City of Cape May was awarded Municipal Aid in the amount of \$174,501.00 for the FY2014 NJDOT improvements on Cape May Avenue (Trenton Avenue to Pittsburgh Avenue).

FY2014 NJDCA Small Cities Grant Application – East Lyle Lane (Perry to Jackson Street) RV&W will open bids for this project on December 9, 2014.

Harbor Lane Bulkhead – Contractor began construction on September 8, 2014. Mr. Roberts reports that the steel sheet pilings have been installed and the project is near completion.

FY2015 NJDCA Small Cities Application – East Lyle Lane (Jackson to Decatur Street) RV&W submitted their engineering report to Mark Blauer to include with the grant application to the DCA. The DCA application was denied.

Mayor Mahaney advises that the City will resubmit the grant application.

FY2013 NJDCA Small Cities Program Surplus Grant Funds – The City received permission from the DCA to use surplus grant funds for ADA beach material, which includes new beach wheel chairs, ground protection mats and modular walkways on the beach.

CITY MANAGER ITEMS

City Manager, Bruce MacLeod, advises that the seasonal beach tags are now on sale in the Tax Office. The pre-season cost for seasonal tags is \$20.00 (December 1, 2014 - March 31, 2015.) Tags may be purchased by mail but will require a \$3.00 handling fee. Free Veteran/Active Military beach tags are also available but will need to be picked up in person with proper Military ID.

Mr. MacLeod announces that the Cape May City Christmas tree lighting will be held at Rotary Park on Friday, December 5, 2014 at 7:00 P.M. The West Cape May Christmas Parade will take place on Saturday, December 6, 2014 beginning at 5:00 P.M. The Poperazzi Holiday Concert will be held at Convention Hall on Saturday, December 13, 2014 at 8:00 P.M. A free Holiday Concert (Angelus Choir) will be held at Convention Hall on Wednesday, December 17, 2014 starting at 7:30 P.M. Finally, the Cape May City Holiday Party will be held at Convention Hall on Saturday, December 20, 2014 from 7:00 P.M. to 9:30 P.M.

Mayor Mahaney reports that the dredging project to clear the Cape May channel is complete.
