## **NEW BUSINESS:**

- City Manager The City Manager reports on a progress meeting he attended regarding the Canning House Lane standpipe. Mr. MacLeod advises that the standpipe sand blasting is completed and the first coat of paint has been applied to the exterior. The intermediate coat of paint will be completed this week. Between January 6 and January 10, 2014, the assembly of the corral, mounted on the top of the standpipe, which will hold the wireless antenna will be completed, advises Mr. MacLeod. The finish coat of paint is scheduled to be applied by January 13, 2014, and Mr. MacLeod reports that the demobilization and removal of the scaffold will be completed January 20, 2014.

John Fleming, 1484 Washington Street, Cape May, asks why the Fire Department has a bar in their building and asks if drinking can take place in a public building. Mr. Fleming feels that it is not appropriate to have a bar in the Fire House.

Mr. MacLeod advises Mr. Fleming that the Volunteer Fire Company houses the building and reports that a draft resolution is being reviewed with the Fire Chief regarding the matter.

Deputy Mayor Murray comments that there is not a "drinking bar" in the building and Mr. Murray advises that he meets at the Fire House once a month and has never seen anyone drinking.

Mr. Fleming asks of the amount of the outstanding water bill owed to the City by the Borough of West Cape May and if the Borough has made any attempt to pay same. Mr. Fleming would also like to know if the residents of the City of Cape May will be responsible for the debt if the Borough does not pay.

Mr. MacLeod advises that the Borough of West Cape May claims that Cape May City owes them money and to date, there has been no payment made by the Borough to the City. The outstanding amount owed by the Borough is \$65,000.00.

Mr. Fleming thanks Mayor and Council for all their efforts.
