## WORK SESSION DISCUSSION ITEMS

#### **ENGINEER REPORT**

1. Mr. Roberts advises that he is awaiting acceptance by the City of the Contractor's proposal for additional funds to perform additional work. RV has recommended the acceptance

of the proposal. If accepted by the City, the total cost for the project will be \$10,800.00 and the project will take one day to complete. City Council agrees to accept the proposal and Mr. Roberts will contact the contractor and press him for a date to complete the repair.

- 2. FY 2011 Road and Utility Improvement Program Jefferson and Corgie Street project. Mr. Roberts anticipates work to begin within the next 10 days. Mr. Roberts also advises that a tree biologist inspected the trees located in the work zone and a report will be forthcoming. The report will contain information regarding realigning the utilities to stay away from the trees as much as possible.
- 3. Canning House Lane underground Storage tank case #23. This matter should be closed prior to the next worksession.
- 4. Canning House Lane underground Storage tank case #48. A Deed Notice is being prepared and will be filed and the matter should be completed by the end of February.
- 5. Madison Avenue-Columbia Avenue Water Tank Rehabilitation Mr. Roberts advises that we are on schedule and anticipate advertising for bids on March 24, 2012.
- 6. FY 2011 NJDCA Small Cities Grant Application Beach access and ADA improvements Bids were opened on December 20, 2012 and the low bidder was Axios, Inc. of Northfield, NJ. This matter is on today's agenda and if awarded, the contractor should begin work by the end of January with completion by May 15, 2012.
- 7. FY 2012 NJDCA Small Cities Grant Application Awaiting a determination of any award.
- 8. FY 2012 NJDOT Municipal Aid Grant Application Awaiting a determination of any award.
- 9. FY 2012 Road and Utility Improvement Program Survey's are being performed today and we will advertise for bids in February with construction to begin in March with completion by the end of May.
- 10. City Hall Rehabilitation-Roof, windows and brick pointing RV has completed a report on the rehabilitation and a report is provided to Mayor and Council for their information and review. Mr. MacLeod inquires as to whether the City will need approval from the HP Office for the repairs and Mr. Roberts advises yes.
- 11. Renewal of Beach Maintenance Permit Mr. Roberts advises that once payment is approved by the City, the application will be forwarded to DEP.

<u>CITY MANAGER ITEMS</u> – Mr. MacLeod advises that he is still working on the update to the Salary Ordinance and information will be available by the next regular City Council meeting. Mr. MacLeod mentions that he recently received information from the County Engineer's Office regarding improvements to the storm water infrastructure from Wilmington Avenue to Brooklyn

Avenue. The effort of the County is to consolidate and eliminate some of the existing outfall pipes in the future. The work will begin January 9, 2012 and the intention is to have the work complete by March 2012.

#### **ATTORNEY ITEMS**

Taxicab Licenses – Mr. Monzo speaks about a new law requiring the licensing of all taxicabs operating within a municipality. He comments that the current legislation is unclear as to whether the City of Cape May will need to license any and all tax cabs that comes into the City. He will research the matter for clarification and advise accordingly.
