NEW BUSINESS:

- A) City Attorney
- B) City Manager Mr. MacLeod announces that there will be an antique car race between 10:00 A.M. and noon on Beach Avenue. He advises that the Clean Communities seminar is being held May 23 through May 25, 2012 and on Memorial Day weekend, beginning on Friday, May 25th from 10:00 A.M. until 12:00 P.M., there will be a grand opening of the new Convention Hall. Light refreshments will be provided and all will be able to tour the facility. On Saturday, May 26, 2012 at 8:00 P.M., Mr. MacLeod advises that the Peter Nero and the Philly POPS will perform a special program. On Sunday, May 27, 2012 at 8:00 P.M. there will be a Jazz Quintet which is free and open to the public. On Memorial Day, Monday, May 28, 2012, Mr. MacLeod advises that the City will honor Veterans with a ceremony at Convention Hall. The USCG Training Center will be featured during this ceremony and the traditional flyover by the Coast Guard and the launching of the memorial flower boat which will occur at Noon. Finally, Mr. MacLeod tells us that there will be a concert in Rotary Park on Monday evening.
- C) City Clerk Ms. Weldon advises that the June worksession will be held on Monday, June 4, 2012 at 1:00 P.M. because of the Primary Election on June 5, 2012.
- D) Councilmembers Deputy Mayor Wichterman comments that May 12, 2012 was the culmination of many years of work by many people with the opening of the new Convention Hall for the Cape May Regional High School Prom. Mr. Wichterman advises that he received nothing but positive comments.

Councilmember Fiocca comments about the success of the prom and all the positive comments from the public.

Mayor Mahaney comments on the success of the prom and the opening of the new Convention Hall. The Mayor advises that if individuals are interested in touring the Hall they may do so between 10 a.m. and 4 p.m. each day. Mayor Mahaney confirms there are three free concerts during the opening week of Convention Hall. Finally, the Mayor announces that the current City Clerk, Diane Weldon, is retiring from governmental service. Mr. MacLeod comments that the City's Police Department is expressing their unhappiness at not having a contract by information picketing. Mr. MacLeod advises that both sides are continuing to negotiate and the intent is to come to an agreement.

City Solicitor Anthony Monzo advises that it is his understanding that the picketing will cease and there will be meetings beginning next week. Mr. Fleming asks if there have been any layoffs in the Police Department and Mr. MacLeod advises that there have been no layoffs.
