Mayor Mahaney announced that under the Open Public Meetings Law, notice of this meeting was sent to the Cape May Star and Wave and The Press and a copy of the agenda was delivered to each Member of Council and was posted on the City Hall Bulletin Board.

Charles Norkis, Executive Director of the Cape May County Municipal Utilities Authority begins by explaining that the rate structure of the CMCMUA in Cape May County is unique because the circumstances in Cape May County are unusual because of the very high summer population and a lower winter population. That change in population effects billing. The treatment facilities were built to accommodate the larger summer population at twice the size and probably twice the cost. The user charges are divided into two components, fixed and variable, and a variable charge would be electricity which varies with the amount of flow, as well as a chemical cost which also varies with the amount of flow. Fixed costs are those costs which do not vary with flow such as debt service, insurance, etc. The fixed costs are 88% of the total bill and the variable charges are 12% of the total bill. Of that 88%, almost 60% is the debt service component. Mr. Norkis provides all with a worksheet and explains how the MUA projects is variable and fixed costs and how those costs convert to dollars. Mr. Norkis talks about how the MUA trimmed their staff and continually tries to cut costs as they are aware of these hard economic times. Upon completion of his presentation, Mr. Norkis entertains questions.

Deputy Mayor Wichterman asks what the amount of the surplus is in the budget of the MUA and Mr. Norkis advises there is no surplus because they are non-profit and their service agreement indicates that if there is any money left, they must return to their customers. They have no retained earnings.

Mayor Mahaney thanks Mr. Norkis for attending.
