He mentions that the County Engineer, Dale Foster, notified the Mayor that next week, the County of Cape May would issue bid information for the street work in front of Convention Hall that will cause Beach Avenue to have some one-lane closures during the month of April. In closing, the Mayor mentions that Peter Nero and the Pops will be performing at our new Convention Hall.
