Chairperson Terri Swain announced that under the Open Public Meetings Law, notice of this meeting was sent to the Cape May Star and Wave and The Press and a copy of the agenda was delivered to each Member of Commission and was posted on the City Hall Bulletin Board.

Trolley Service Summary 2009 – Ridership up 20% over 2008, funding fell short, tourist are relying more on trolley. Income requirements for 2009 are \$400/day x 66 days = \$26,400. Service ran July 3, 2009 to September 6, 2009, 12Noon to 9PM daily in a continuous loop in Cape May, trolley fare \$1.00 one-way. (Motels put most people on) Commission members asked about extending hours to coincide with events for 2010 and also looking to make trolley fare free. Mr. Adelizzi proposed the same budget for 2010, and is a little reluctant to change major parameters of operation. He recommends stay with fare, look at your budget, and look at morning hours. Trolley has capacity of running DVD's and has advertising space for those participating in the service. Mr. Adelizzi can provide flyers to ride free (all park & ride people ride free) trolley stops at any corner on route, try to maintain a 20 minute schedule.

Members discussed ways of selling trolley service to BID and other organizations who are not participating, also discussed advertising, signage, hours of operation. Tourism's ultimate goal is a fare free trolley, members will reach out to Realtors, Chamber, Bid. Mr. Adelizzi is at Tourism's disposal for next meeting, committee thanked Dick for coming.

Other Guests in attendance: Mayor Mahaney, Hillary Pritchard

Mr. Andy questioned Mayor about the water deficit in the City's budget, the Mayor explained the City's need to have 25% guaranteed revenue and understands the burden but Council had to make the tough decision.
