Business/Discussion: City of Cape May - Rules & Regulations

Rules & Regulations committee member Mr. Elwell briefed the membership of this undertaking. The eight page document was reviewed by members with a discussion on Section IV, pg. 5 Section A- Members should: #3; regarding the review of any correspondence, plans, maps must be distributed to the members a least four (4) days prior to the meeting. Discussion ensued regarding what documents were submitted for the ten (10) days prior and was clarified by Mr. Neidig that the members should consider a revision to the section and gave an example of verbiage: Additional documents which are not required to be presented at least ten (10) days prior as per the Municipal Land Use Law must be delivered to Board Members by 12:00 noon via e-mail or mail four (4) business days prior to the meeting date. Section VI pg. five (5) Item B. Work Sessions – omitting; except June, July and August. Debate ensued regarding the ten (10) days prior verbiage and wanted clarification (business or calendar) days. Page seven (7) Section IX Procedure for Hearing Applications, Item #9 summation of finding of fact by Board Members with Mr. Neidig elaborating on the procedure. Members decided to table the Rules and Regulations until the Boards Attorney and Engineer review the document.

Chairperson Bezaire announced the Rules and Regulations for the Internal Organization and Procedures would be revised, revisited and voted on July 27, 2010.

Member Ms. Weeks wanted guidance regarding the Environmental aspects of an application. Both Mr. Neidig and Mr. Hurless responded to her questions and clarified that the State of New Jersey controls and it falls out of the City's jurisdiction. Mr. Hurless then asked Ms. Weeks if the Environmental Commission would submit correspondence prior to the application being heard to himself for review and the Planning Board Secretary for the file.

Meeting opened for public comments at 7:40pm with Charlotte Todd 651 Hughes Street, Chairperson of the City of Cape May Environmental Commission stated they respond to major application and thanked the Board for addressing their concerns.

Mr. Bezaire announced that on Tuesday, July 27, 2010 at 7:00pm, the Planning Board would review the proposed zoning changes of the R2 and R5 Zoning Districts along the area of Washington Street and Texas Avenue. Mary Rothwell, Board Secretary, sent notices to everyone within 200 feet.
