Call for Immediate Restoration of Energy Taxes to Municipalities

WHEREAS, taxes on gas and electric utilities were originally collected by the host municipalities to be used for local purposes and to compensate the public for the use of their rights of way; and,

WHEREAS, when the State made itself the collection agent for these taxes, it promised to dedicate the proceeds to municipal property tax relief; since, just as municipalities collect property taxes for the benefit of school districts, counties and other entities, the State is supposed to collect Energy Taxes for the benefit of municipal governments; and,

WHEREAS, for years State budget makers have diverted funding from Energy Taxes to fund State programs; and instead of being spent on local programs and services and used to offset property taxes, the money has been spent as successive Legislatures and Administrations have seen fit; and,

WHEREAS, while the State may need to have the right to override the statutory dedication of these revenues to local governments, in order to deal with emergencies and crises that may occur; current State policymakers should not exercise that right automatically; and,

WHEREAS, while that right should be the exception, it has become the rule; and,

WHEREAS, by keeping flat funding of the appropriation for CMPTRA year-over-year, State Budget makers have been able to continue collecting Energy Taxes, while keeping additional revenue that should have been returned to provide property tax relief; and,

WHEREAS, in SFY 2023, the State did provide some much-needed relief in the allocation of \$75 million of new funds identified as the Municipal Relief Fund; and,

WHEREAS, in SFY 2024, the State allocated \$150 million in Municipal Relief Funds, however, in SFY 2025 and as proposed in SFY 2026, no allocation will exist; and,

WHEREAS, in SFY 2024, the Energy Tax Receipts Program should have received over \$350 million to restore municipalities back to 2008 levels; however, the State's diversion of Energy Taxes has continued to grow causing more of a financial gap; and,

WHEREAS, the cumulative impact of years of flat funding and underfunding has left many municipalities with serious needs and burdensome property taxes; and,

WHEREAS, local elected officials are in the best position to decide the best use of these resources, which were always intended to fund local programs and services.

BE IT FURTHER RESOLVED that the Municipal Council of the Borough of Waldwick respectfully call on State policymakers to end the diversion of our municipal resources to cover State spending and to provide us with this important tool to relieve the worst-in-the-nation property tax burden borne, for too long, by the people of New Jersey; and,

WHEREAS, Harrison Avenue Redevelopment LLC, Harrison Avenue, Block 107, Lots 1, 3 5, 7-11, Waldwick, NJ 07463 received site plan approval for the construction of a new 4-story mixed-use building containing a retail use on the first floor and twenty-one (21) residential apartments on the second through fourth floors. In addition, twenty-one (21) townhouse style residential homes are proposed along Harrison Avenue between Frederick Street and West Prospect Street. Formal Planning Board approval was given on July 9, 2025; and,

Choosing Not to Renew the Crown Castle Lease and to Assume Ownership of the Monopole at 19 Industrial Park

WHEREAS, the Borough of Waldwick ("Borough") is the landlord under a Lease Agreement dated December 28, 2004, as amended, with New Cingular Wireless PCS (subsequently assigned to CACATT LLC, a subsidiary of Crown Castle USA) for portions of Lot 42, Block 154, commonly known as 19 Industrial Park, Waldwick, New Jersey 07463 ("Premises"), with said Lease Agreement providing for the installation of a 125 foot telecommunications tower (the "Monopole") and fenced off compound area (the "Lease Agreement"); and,

WHEREAS, the Lease Agreement is scheduled to expire on August 17, 2025; and,

WHEREAS, pursuant to Paragraph 10 of the Lease Agreement, the Borough has the option to assume ownership of the Monopole located on the Premises upon expiration of the Lease Agreement; and,

WHEREAS, the Borough has determined that it is in its best interest to exercise the aforementioned option and assume ownership of the Monopole and manage its use to maximize public benefits and ensure compliance with all applicable laws and regulations, including N.J.S.A. 40A:12-3; and,

WHEREAS, in accordance with N.J.S.A. 40A:12-14, the Borough is required to seek bids through open public bidding for the leasing of municipally owned real property and capital improvements, including telecommunications tower space and ground space, to private parties; and,

WHEREAS, the Borough may seek bids for the continued colocation of wireless facilities on the Monopole and associated ground space, providing fair opportunities for all potential tenants, including Crown Castle and other existing tenants.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Waldwick, County of Bergen, State of New Jersey, as follows:

1. **Non-Renewal of Lease:** The Borough elects not to renew the Lease Agreement with CACATT LLC (Crown Castle) upon its expiration on August 17, 2025.
2. **Assumption of Ownership:** The Borough exercises its option, pursuant to Paragraph 10 of the Lease Agreement, to assume ownership of the Monopole located on the Premises upon the lease's expiration.
3. **Future Use and Management:** The Borough may issue a request for proposals (RFP) for the continued colocation of wireless facilities on the Monopole and associated ground space, in compliance with all applicable laws and regulations.

4. **Consolidated Resolution:** The Borough's decision to assume tower ownership and right to initiate the public bidding process for colocation rights and associated ground space is hereby consolidated into this single resolution as both steps are integral to the Borough's exercise of its property and regulatory authority under applicable state law and the Lease Agreement.
5. **Right to Establish Rent Thresholds:** The Borough expressly reserves the right to establish minimum annual lease payment thresholds, including but not limited to those applicable to each tower elevation and associated ground space, as part of any forthcoming bidding process; said minimum thresholds shall be determined by the Borough in its discretion prior to the issuance of any request for proposals and incorporated therein as a condition of bid responsiveness under N.J.S.A. 40A:12-14.
6. **Notification and Coordination:** The Borough Administrator and telecommunications consultant, Hoplite Communications LLC, are authorized to notify Crown Castle and other existing tenants of this decision and to facilitate a seamless transition of ownership and management.
7. **Public Interest:** This decision is made in the best interest of the Borough and its residents, assuming ownership of the Monopole will optimize revenue and provide greater and unified control over its use.

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to Crown Castle, all existing tenants, and any other relevant parties to effectuate its provisions.

Chapter 48 Fees

§48:1-10.3 Escrow for off-duty and outside employment by police officers.

4. On completion of the services, the private person or entity, non-profit and other governmental entity for which the off-duty patrol officer services are provided, shall be given with an itemization of disbursements from the escrow account which will include the actual overtime rate paid to each officer the fringe benefit costs of that officer while on duty. There shall also be assessed a charge for the use of the vehicle in accordance with § 48:1-10-2 and an administrative fee of ~~6%~~ 8% will be levied on the personnel costs (salary and fringe benefits). If there is any balance remaining in the escrow account it shall be returned to the posting entity in accordance with Borough payment policy without interest.
