#### MEETING MINUTES September 4, 2025

<u>Call to Order</u>: Carl Johnson, Chairman called the September 4, 2025, meeting of the Code Enforcement Committee to order at 10:30 a.m. in the Assembly Room at Plymouth Town Hall.

<u>Fire Exits</u>: Carl Johnson, Chairman made note of the fire exits and explained emergency exit routes to the Committee.

<u>Roll Call</u>: Carl Johnson, Chairman & Public Works Director; Raymond Kovaleski, Fire Marshal; Police Chief Karen Krasicky, Kelli Lombard, Torrington Area Health; Harold Sturgeon, Robert White, Fall Mountain Property Association; Margus Laan, Land Use and Linda Schnaars as Recording Secretary. Also, in attendance: Janet Tye.

<u>Approval of Minutes</u>: Carl Johnson, Chairman entertained a motion to accept the minutes of the previous meeting of August 7, 2025.

MOTION to approve the minutes was made by Harold Sturgeon and seconded by Police Chief Karen Krasicky. The motion passed with one abstention.

#### Discussion Items:

- a. 4 Chidsey Terrace Chairman Johnson talked to the town attorney. The attorney stated to document every step of the condemnation so the building can be demolished. The Building Official needs to send a new letter as the procedure has to start over.
- b. 156 Main Street Janet Tye stated "rumor" the property was sold. Chairman Johnson reported the town received some of the funds.
- c. **4 Bernice Avenue** Chairman Johnson reported there is no Zoning Enforcement Officer. This will stay on the active list.
- d. 34 Makara Street Chairman Johnson reported liens are on the property. It is being cleaned up and put on the market.
- e. 98 Allen Street Kelli Lombard reported there is overgrown grass. There are no health code violations. This will be removed from the list.

f. 244 Main Street – Chairman Johnson talked to the contractor. The property is ready to be demolished. Chairman Johnson will reach out to Eversource gas to get it disconnected. Demo can begin early next week.

I am writing with regards to the above listed property. According to the town of Plymouth, CT, Telesh Inc. is listed as the owner of 47 Fall Mountain Terrace. As the Enforcement Officer for the Association acting on the authority of Section VII of the FMLPOA Charter, also stated in Section X of the by-law book, please be advised you are in violation of by-laws found under section 2.

#### <u>Violations:</u> Lawn and yard maintenance.

In accordance with the established procedures of the Association, this letter serves as notification of By-Law violations. If these mentioned violations are not remedied within <u>14</u> days of the date of this letter a formal violation will be issued imposing an initial fine of twenty-five dollars (\$25.00) and up to twenty-five dollars (\$25.00) per day until each violation mentioned above has been corrected.


If we can ask that the grass, bushes and debris be maintained while under your ownership, it would be greatly appreciated.
