Present for the Executive Session were Vijay Dora, Joe Green, Jeff Scott; Joe Kilduff, Margus Laan, and Eliza Crapo.

Mayor Joe Kilduff called the Tax Incentive Committee meeting back into Regular Session at 1:21 p.m.

**Action, as may be necessary, from Executive Session**

Economic Development Commission Vice Chairman Jeff Scott made a motion, seconded by Town Councilman Joe Green, to approve the Tax Abatement Agreement for the development of 128 North Harwinton Avenue, Terryville, between the Town of Plymouth and Premiere Properties LLC.

Discussion: When questioned by Town Councilman Joe Green, Mayor Joe Kilduff stated Premiere Properties, LLC, can assign the Agreement to a subsequent purchaser of the Property and Project, with the consent of the Town, which consent shall not unreasonably be withheld; provided, however, no consent shall be required in order to assign the Agreement. He further stated that if the Town had a good reason, it could deny it; should Premier Properties, LLC, transfer it, it would transfer with the consent of the Town.

Vote: This motion was approved unanimously.

Town Councilman Joe Green made a motion, seconded by Economic Development Commission Vice Chairman Jeff Scott, to approve the Tax Abatement Agreement for the development at Prospect Street School by and between the Town of Plymouth and Premiere Properties, LLC. This motion was approved unanimously.
