General Public Comment:

- **Electric Scooter and Bicycle Study:** Completed, will address with Mayor and Council at a future meeting.

- **PSE&G Energy Strong Project** – Phase 2, Started no current issues.
- **Ordinance Recommendation – Passive Recreation/Non-Paved Surfaces:** The Police Department recommends an ordinance regarding driving on passive recreation areas or non-paved surfaces (“paper streets”).
- **Ordinance Recommendation – Parked Trailers:** The Police Department recommends an ordinance prohibiting parked trailers on a public roadway without an attached motor unit.
- **Ordinance Recommendation – Covered Vehicles:** The Police Department recommends an ordinance prohibiting vehicles covered on a public roadway if registration plates are not visible.
- **Ordinance Recommendation-No Stopping, standing, or parking:** The Police Department recommends an ordinance prohibiting vehicles stopping or standing within the River Edge Road Train Station Parking Lot.
- **Ordinance Recommendation- Meter Parking in the municipal owned parking lots:** The Police Department recommends an ordinance authorizing timed parking stalls within the municipal parking lots.
- **Pedestrian Grant:** The River Edge Police Department applied for another round of grant funding and we are waiting to see if we are awarded.
