Mayor and Council Regular Meeting October 9, 2025 7:00 P.M.

CALL TO ORDER -

A Regular Meeting of the Mayor and Council of the Borough of River Edge was held in person in Council Chambers of the River Edge Municipal Building located at 705 Kinderkamack Road, River Edge, NJ 07661 and virtually via Zoom on October 9, 2025. The meeting was called to order at 7:00 p.m. by Mayor Thomas Papaleo.

Mayor Papaleo asked for a moment of silence for the Palestian/Israeli peace agreement. Councilman Benson then led those present in a salute to the flag.

PROCLAMATIONs & AWARDS

Diwali Day

Mayor Papaleo read the following proclamation into the record:

PROCLAMATION DIWALI

WHEREAS, Diwali comes from the Sanskrit word 'Deepavali', a row of lights, while the festival is known as 'Festival of Lights', symbolizing the victory of light over darkness, goodness over evil, and knowledge over ignorance; and

WHEREAS, Diwali, is celebrated igniting traditional clay lamps 'Divas', in the autumn of

each year, at the end of harvest season, during 'Hindu Heritage' month, beginning on a New Moon, the darkest night of the Hindu calendar ("Panchanga"), Diwali date being determined by the Lunar calendar each year; and

WHEREAS, Diwali is celebrated over five days by Hindus, Sikhs, Jains, and some Buddhists, throughout Bergen County, and around the world; each with its own significance and traditions, the five days of Diwali being "Dhanteras", "Naraka Chaturdashi", "Diwali", "Govardhan Puja" and "Bhai Dooj"; ,and

WHEREAS, Diwali includes many traditions, such as charitable giving ("dana"), providing selfless service ("seva"), gathering with friends and family for prayer ("Puja"), exchanging gifts, eating sweets, setting off fireworks and decorating homes with colorful rice, sand, chalk or flower patterns ('rangolis'); and

WHEREAS, for Hindus, Diwali marks Lord Rama's return to his home, "Ayodhya", after defeating King Ravana and is therefore a celebration of goodness over evil, and light over darkness; and

WHEREAS, for Sikhs, Diwali is the day when the sixth founding Sikh Guru, Guru Hargobind, was released from confinement by the Mughal Emperor Jehangir; and

WHEREAS, for Jains, Diwali symbolizes the attainment of Self-Realization, ("Nirvana"), by Lord Mahavira, the last of the Tirthankaras, who were the great teachers of Jainism; and

WHEREAS, for Buddhists, Diwali represents the day Emperor Ashoka chose the peaceful path of Buddhism over destruction and carnage; and

WHEREAS, the holiday is a uniting force, as it is celebrated by the majority of people from India, regardless of their faith and is celebrated by more than one billion people worldwide; and

WHEREAS, Bergen County is the home to nearly 35,000 Indian-American residents, who strengthen and enrich 70 municipalities with their valued history, culture, heritage and vibrant traditions, while diversity represents one of the Borough of River Edge's greatest strengths, and the Borough joins with the people of Asian Indian heritage across New Jersey and those around the world celebrating Diwali; and

NOW, THEREFORE, BE IT RESOLVED that I, Mayor Thomas Papaleo, Mayor of the Borough of River Edge, County of Bergen in the State of New Jersey, do hereby recognize and proclaim October 18th through October 22nd as 'FIVE DAYS OF DIWALI' with October 20th, 2025 as DIWALI DAY; and we call this observance to the attention of all our residents and public officials of Bergen County, and call upon our residents to learn and recognize the religious, cultural and historical significance of the festival, observing the holiday with appropriate activities and programs.

Pamela Gould, 683 Bogert Road, Environmental Protection Commission member, advised that a NJ DEP grant was identified with a quick turnaround time. She explained the requirements and advised that New Milford, Teaneck, and Hackensack have joined together in applying for this grant and would like River Edge to join.

Borough Administrator Aportela advised that there is a very tight deadline of two weeks, and as such, there is not sufficient time to apply for this grant. She noted that the DPW is working with the Borough Engineer on renewing the Borough's Stormwater Tier A Permit, and once it is known what work and requirements are entailed, a project for this grant can be developed. She advised that the grant can be explored with more sufficient time next year.

Councilman Glass requested that Borough Administrator Aportela inquire as to why this grant was not on the Grant Consultant's radar.

AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF RIVER EDGE, CHAPTER 17, ENTITLED 'BOARDS, COMMISSIONS, AND COMMITTEES"

BE IT ORDAINED by the Mayor and Council of the Borough of River Edge, County of Bergen, State of New Jersey, as follows:

<u>Section 1</u>. Chapter 17 entitled "Boards, Commissions, and Committees" shall be amended with the addition Article II entitled "Attendance Policy":

§ 17-2 Attendance Policy for Meetings

The office of any person appointed by the Mayor and Council to a board, committee, commission or other municipal agency, shall be deemed vacant if such person fails to attend and participate at meetings of such body for a period of six (6) consecutive weeks or for three (3) consecutive meetings, whichever shall be longer in duration, without being excused by a majority of the board, committee, or commission membership.

Such board, committee, commission or other agency may refuse to excuse only with respect to those failures to attend and participate that are not due to legitimate illness. In such event, such body shall notify the Mayor and Council in writing of its determination. Mayor and Council shall determine if the circumstances presented establish a basis for removal.

§ 17-3 Attendance Policy for Events.

For boards, committees, and commissions that hold Borough sponsored events, the office of any person appointed by the Mayor and Council to a board, committee, commission or other municipal agency, shall be deemed vacant if such person fails to attend and participate at events of such body for a period two (2) consecutive events, without being excused due to a legitimate illness by a majority of the board, committee, or commission membership.

- Section 2. Any and all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.
- Section 3. In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

AN ORDINANCE TO AMEND CHAPTER 286 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF RIVER EDGE, ENTITLED "MULTIPLE DWELLINGS, REGISTRATION OF".

BE IT ORDAINED by the Mayor and Council of the Borough of River Edge that the following amendments to Chapter 286 entitled "Multiple Dwellings, Registration of" are hereby approved:

Section 1. Section 286-1, entitled "Statement of ownership" shall be replaced in its entirety with the following:

§ 286-1 Statement of ownership.

Every owner of premises containing three (3) or more apartments used for residential purposes shall file, under oath, with the Health Officer of the borough, a statement containing the address of the premises, the name and address of the owner thereof and the number of apartments in such premises. If the owner is a corporation, such statement shall be made under oath by the president, the vice president or secretary of the corporation.

<u>Section 2</u>. Section 286-2, entitled "Statement of vacancy" shall be replaced in its entirety with the following:

§ 286-2 Statement of vacancy.

Within ten (10) days after a tenant moves out of and vacates an apartment in any residential premises containing three (3) or more dwelling units, the owner of such premises shall file with the Health Officer a statement under oath containing the address of the premises and the number or other specific designation of the apartment vacated. If the owner is a corporation, such statement shall be made under oath by the president, vice president or secretary of the corporation.

- Section 3. Any and all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.
- <u>Section 4.</u> In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.
- Section 5. This Ordinance shall take effect immediately upon final passage and publication as required by law.

BOROUGH OF RIVER EDGE ORDINANCE NO. 25-18

AN ORDINANCE AMENDING SECTIONS 384-7 AND 384-8 OF ARTICLE II OF CHAPTER 384 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF RIVER EDGE, ENTITLED "TREES"

BE IT ORDAINED by the Mayor and Council of the Borough of River Edge, County of Bergen, State of New Jersey, as follows:

Section 1. Section 384-7, entitled "Tree replacement requirements", of Article II, Tree Removal and Replacement of Chapter 384, Trees, of the Code of the Borough of River Edge, is hereby amended to read as follows:

- A. Any person who seeks to remove any street tree, unless exempt under § 384-8, shall be required to obtain a tree removal permit from the Superintendent or designee of the Department of Public Works and shall be subject to the requirements of the Tree Replacement Requirements Table below.
- B. Any person who seeks to remove any tree with a DBH of six inches or more from any property within the Borough of River Edge, unless exempt under § 384-8, shall be required to obtain a tree removal permit from the Superintendent or designee of the Department of Public Works and shall be subject to the requirements of the Tree Replacement Requirements Table.
- C. The species type and diversity of replacement trees shall be in accordance with the most recent list of native trees published by the New Jersey Department of Environmental Protection which shall be listed in Appendix A
- D. Replacement tree(s):
 - 1) shall be replaced in kind with a tree that has an equal or greater DBH than the tree removed or meet the tree replacement criteria in the table below;
 - 2) For non-construction removals, must be planted within 12 months of the date of removal of the original tree(s) or at an alternative date specified by the Borough;
 - 3) If a construction permit is issued, replacement must be completed before a certificate of occupancy is issued by the Building Department;
 - 4) shall be monitored by the applicant for a period of two years to ensure their survival and shall be replaced as needed within 12 months; and
 - 5) Shall not be planted in temporary containers or pots, as these do not count towards tree replacement requirements.
 - 6) and the permit site will be reinspected before close out of the permit.

Tree Replacement Requirements Table:

Category	Tree Removed (DBH)	Tree Replacement Criteria (See Appendix A)
4	DBH of 2.5" (for street trees) or 6" (for non-street trees) to 15.99"	Replant 1 tree with a minimum tree caliper of 1.5" for each tree removed
2	DBH of 16" to 25.99"	Replant 2 trees with minimum tree calipers of 1.5" for each tree removed
3	DBH of 26" to 35.99"	Replant 3 trees with minimum tree calipers of 1.5" for each tree removed
4	DBH of 36" or greater	Replant 4 trees with minimum tree calipers of 1.5" for each tree removed

- E. Administration or application fee for the processing of each tree removal permit is \$100. Any subsequent application or request shall be subject to the same fee requirement. All application fees will be deposited into the shade tree fee account. A refundable bond in the amount of \$400 per tree must be provided at the time of application. Bonds will be refunded once the replacement tree or trees have been planted and inspected by the Superintendent of Public Works or designee.
- F. Replacement alternatives: Unless the Superintendent or designee of the Department of Public Works has determined otherwise, all property owners must replace any tree removed with 100% of the trees that are required in Section 384-7(D) (Tree Replacement Requirements Table) on the approved tree permit that allows the tree removal be done on the property. For any trees that are not replanted on the property where the tree removal activity occurred, with the approval of the Superintendent or designee of the Department of Public Works, the applicant shall do one of the following:
 - (1) Plant replacement trees in a separate area(s) approved by the municipality.
 - (2) Pay a fee of \$400 per tree not replanted in accordance with the tree replacement criteria in the above table. This fee shall be placed into the Borough's Shade Tree Trust Fund.
- Section 2. Section 384-8, entitled "Exemptions", of Article II, Tree Removal and Replacement of Chapter 384, Trees, of the Code of the Borough of River Edge, is hereby amended to read as follows:

All property owners shall comply with the tree replacement standard outlined

above, except in the following cases. Proper justification shall be provided, in writing, to the municipality by all property owners claiming an exemption including photos, a detailed explanation as to why they should be exempt and any statements from a licensed tree expert or arborist.

- A. Tree farms in active operation, nurseries, fruit orchards, and garden centers;
- B. Properties used for the practice of silviculture under an approved forest stewardship or woodland management plan that is active and on file with the Borough;
- C. Any trees removed as part of a municipal or state decommissioning plan. This exemption only includes trees planted as part of the construction and predetermined to be removed in the decommissioning plan;
- D. Any trees removed pursuant to a New Jersey Department of Environmental Protection (NJDEP) or U.S. Environmental Protection Agency (EPA) approved environmental clean- up, or NJDEP approved habitat enhancement plan;
- E. Approved game management practices, as recommended by the State of New Jersey Department of Environmental Protection, Division of Fish, Game and Wildlife;
- F. Hazard trees may be removed with no fee, provided however, that the grinding of the tree stump is required as part of the removal process.

Section 3. Any and all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent of such conflict or inconsistency.

Section 4. In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 5. This Ordinance shall take effect immediately upon final passage and publication as required by law.
