

**BOROUGH OF RIVER EDGE**  
**RESOLUTION #26-148**

**Authorize Purchase and Installation of Flooring – Public Safety Building**

WHEREAS, the purchase and installation of flooring for the Public Safety Building was authorized in the 2026 capital budget; and

WHEREAS, the Borough of River Edge is a member (ID# 10112) of Sourcewell (formerly known as National Joint Powers Alliance NJPA) as permitted by PL 2001, c. 139; and

WHEREAS, the Department of Public Works Superintendent, Jason Milito prepared a cost savings determination recommending the purchase through the national cooperative; and

WHEREAS, the Department of Public Works Superintendent, Jason Milito obtained quote from Flooring Concepts of NJ, a local distributor for Shaw Integrated and Turf Solutions, Inc. for the purchase and installation of carpeting, tile, and epoxy throughout the Public Safety Building under Sourcewell Contract # 061323-SII in the amount of \$150,304.00; and

WHEREAS, a notice of intent to award a contract under a national cooperative purchasing agreement was published on the Borough website on May 4, 2026, pursuant to PL 2025, c. 72; and

WHEREAS, Flooring Concepts of NJ, has submitted a Business Entity Disclosure Certification on May 4, 2026, which certifies that the company has not made any contributions to any political or candidate committee in the Borough of River Edge in the previous one year that would render the company ineligible to be awarded this contract, and that the proposed contract prohibits Flooring Concepts of NJ from making any such reportable contributions through the term of the contract; and

WHEREAS, Flooring Concepts of NJ has submitted a Political Contribution Disclosure Form on May 4, 2026, required pursuant to NJSA 19:44A-20.26; and

WHEREAS, Chief Financial Officer Chris Battaglia has advised that funding is available for this purchase.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of River Edge that the Department of Public Works Superintendent, Jason Milito is authorized to issue a purchase order for purchase and installation of carpeting, tile, and epoxy throughout the Public Safety Building to Flooring Concepts of NJ, having its principal office at 289 Route 33, Building C in Manalapan, NJ 07726 in the amount of \$150,304.00 under Sourcewell Contract #061323-SII.
