WHEREAS, the Borough Engineer has reviewed the base bid submitted by Gallen Contracting, Inc., in the amount of \$1,428,694.00 along with the alternate bid items A1, A2, A5, and A9 in the amount of \$65,079.00 and has recommended the base and alternate bid be awarded to Gallen Contracting, Inc. for a total of \$1,493,773.00; and

WHEREAS, Chief Financial Officer Chris Battaglia has certified funds are available for this project.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of River Edge that a contract for the FY19, FY20 & FY24 KBG Field Improvements Project shall be awarded to Gallen Contracting, Inc., having its principal office at 11 Birch Street, Midland Park, NJ 07431 in the amount of \$1,493,773.00 based on the base and alternate bid items A1, A2, A5, and A9, submitted on August 12, 2025; and
