Authorize Purchase, Delivery, and Installation of
Council Chambers Recording System Upgrades

WHEREAS, the Borough of River Edge is a member of The Interlocal Purchasing System (TIPS), Public Sector as permitted by PL 2001, c. 139; and

WHEREAS, the Borough Administrator/Qualified Purchasing Agent has prepared a cost savings determination recommending the purchase through the national cooperative; and

WHEREAS, the Borough Administrator/Qualified Purchasing Agent obtained quotes from Business Information Systems, Inc. (BIS) for the purchase, delivery, and installation new audio/visual equipment for Council Chambers in the total amount of \$55,736.69; and

WHEREAS, a notice of intent to award a contract under a national cooperative purchasing agreement was published in the Record on June 29, 2025; and

WHEREAS, Business Information Systems, Inc. has submitted a Business Entity Disclosure Certification on June 25, 2025, which certifies that the company has not made any contributions to any political or candidate committee in the Borough of River Edge in the previous one year that would render the company ineligible to be awarded this contract, and that the proposed contract prohibits Business Information Systems, Inc. from making any such reportable contributions through the term of the contract; and

WHEREAS, Business Information Systems, Inc. has submitted a Political Contribution Disclosure Form on June 25, 2025, required pursuant to NJSA 19:44A-20.26; and

WHEREAS, Chief Financial Officer Chris Battaglia has advised that funding is available for this purchase.

NOW THEREFORE BE IT RESOLVED that the Mayor and Council of the Borough of River Edge confirm the issuance of purchase orders for the purchase, delivery, and installation of new audio/visual equipment for Council Chambers to Business Information Systems, Inc. having its principal office at 6600 Park of Commerce Blvd., Boca Raton, FL 33487 in the total amount of \$55,736.69.
