**RESOLUTION APPOINTING CLEARY GIACOBBE ALFIERI JACOBS, LLC
AS MUNICIPAL LAND USE BOARD ATTORNEY FOR 2026**

WHEREAS, the Municipal Land Use Board of the Borough of River Edge (the “Board”) requires the services of a Professional Attorney; and

WHEREAS, the Borough has utilized the non-competitive process to appoint its Land Use professionals; and

WHEREAS, such services constitute a professional service within the meaning of N.J.S.A. 40A:11-5 for which public bidding is not required; and

WHEREAS, Cleary Giacobbe Alfieri Jacobs, LLC has submitted its proposed contract and has completed and submitted a Business Entity Disclosure Certification, which certifies that its law firm has not made any contributions to any political or candidate committee in the Borough in the previous one year that would render it ineligible to be awarded this contract; and

WHEREAS, it is in the best interest of the Board to accept said proposal; and

WHEREAS, the Board determined to retain Brian M. Chewcaskie, Esq., with offices at Cleary Giacobbe Alfieri Jacobs, LLC, 169 Ramapo Valley Road, Oakland, New Jersey 07436 as its Land Use Board Attorney for the year commencing January 1, 2026 through December 31, 2026.

NOW THEREFORE, BE IT RESOLVED by the Borough of River Edge Municipal Land Use Board that this Resolution is adopted as confirmation of the appointment of Cleary Giacobbe Alfieri Jacobs, LLC for the period commencing January 1, 2026 and ending on December 31, 2026, and shall be paid for services rendered in accordance with the Request for Qualifications and the contract entered into between the parties.

BE IT FURTHER RESOLVED that this contract is awarded for the period beginning January 1, 2026 and ending December 31, 2026.

BE IT FURTHER RESOLVED that the Resolution adopted on this 28th day of January, 2026 memorialized the action taken by the Board in accordance with N.J.S.A. 40:55D-10(g), as set forth above, at its January 14, 2026 meeting, and that a certified copy of this Resolution be forwarded to: (1) Brian M. Chewcaskie, Esq.; (2) Borough Attorney and (3) River Edge Purchasing Agent.
