Mayor Kownacki read by title, an ordinance entitled, AN ORDINANCE AMENDING SECTION 409, THE APARTMENT AND TOWNHOUSE DISTRICT, ARTICLE IV ZONING DISTRICT REGULATIONS"

# AN ORDINANCE AMENDING SECTION 409, THE APARTMENT AND TOWNHOUSE DISTRICT, ARTICLE IV ZONING DISTRICT REGULATIONS

WHEREAS, the Township Council of the Township of Lawrence ("Township Council"), a municipal corporation in the County of Mercer, State of New Jersey, finds that the public health, safety, morals, and general welfare of the community shall be promoted by the revision and amendment of the Land Use Ordinance ("LUO") of the Township to implement the Housing Element and Fair Share Plan of the municipality; and

WHEREAS, the Planning Board of the Township of Lawrence has adopted a Master Plan that comprehensively provides a foundation for the appropriate use, regulation and development of lands for affordable housing in the Township in a manner which will promote the public health, safety, morals, and general welfare; and

WHEREAS, these amendments to the LUO are necessary to reduce barriers to inclusionary development by correcting minimum lot size and lot designations; and

WHEREAS, the Municipal Land Use Law at N.J.S.A. 40:55D-62a requires substantial consistency of the provisions regulating zoning and land use with the adopted Master Plan; and

WHEREAS, the Planning Board has determined that the revisions and amendments to the Land Use Ordinance set forth herein are consistent with the goals and objectives of the Master Plan and more specifically the Housing Element to complete the necessary steps to obtain an amended Judgment of Repose from the Court and therefore favorably recommends to the Township Council that Section 409 of the LUO be so amended; and

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Lawrence that the Land Use Ordinance be hereby amended as follows:

<u>Section 1</u>. Article IV Zoning District Regulations, Section 409 Apartment and Townhouse District is amended and supplemented as follows (additions are shown as <u>thus</u>; deletions are shown as <u>thus</u>);

. . . . .

- F. General District Regulation. In the Apartment and Townhouse district, the following general regulations shall apply:
  - 1. Minimum gross acreage of tract:

**4.5** acres

. . . . .

**Section 2.** §301, Zoning Map, shall be modified by designating the AT-3 Overlay to Block 4201.01, Lot 32.02.

#### Repealer:

All ordinances or parts of same inconsistent with any provision of this ordinance are hereby repealed to the extent of such inconsistency.

# Severability:

If any section, paragraph, sentence, clause or phrase of this ordinance shall be declared invalid for any reason, the remaining portions of said ordinance shall not be affected thereby and shall remain in full force and effect.

#### Effective Date:

This ordinance shall take effect twenty days (20) days after adoption thereof.

# Manager's Report -

Mr. Nerwinski submitted invoice listings for the month of August 2021 in the amount of \$2,077,426.10.

Mr. Nerwinski reported that the Township is advancing their inquiry into including an additional platform for the website that will improve the services that they provide to the residents and businesses, primarily, with the Construction Department to streamline the application process and have it done online by creating a portal for businesses and residents to see the progress of their application as it works through the various departments and the information will be instantaneous as opposed to making or waiting for responding telephone calls.

Mr. Nerwinski advised that they met with a couple of vendors and they have seen a couple of presentations and they are now focusing on one vendor who will do different departmental presentations. One of the things that proved apparent from the presentations is a reduction of time in doing OPRA requests as this particular platform provides a lot information online and other municipalities have seen a significant drop in OPRA requests given the information is readily available as it relates to properties and things that people tend to be interested in on a consistent basis such as real estate agents. Hopefully, this will be a nice situation in reducing OPRA requests for the Municipal Clerk, and he will have more information for the Council at the next meeting.

Mr. Roskos reported that they are going to file a Motion to amend the Township's Complaint against Trenton Water Works, and advised that Mr. Oakley informed him today that the study of fire hydrants was expanded and none of the hydrants in the other water franchise areas are deficient... they all work. The only deficient hydrants they

have are in the Trenton Water Works franchise area. Therefore, they are going to bring that to the Court's attention in the form of an Amended Complaint next week. Mr. Nerwinski noted even the hydrants in other areas that did not work, the Utilities response times were much faster than Trenton Water Works.

Further, she is looking forward to working collaboratively with the Town Council as they address the issues of the Human Relations Committee and any forward movement in that regard. In the spirit of the Vereen Family, and their rich history in the Township, they owe a responsibility to ensure that all people and citizens feel included, valued and recognized by this august body.
