b. 2923 Main St.

Architect, Max Hayden, presented plans for expansion and refurbishing of this key structure. Despite it's designation, this house has had a history of un-sympathetic alterations over the years. The existing roof is of asphalt shingles – looking to replace with standing seam metal roofing. Considering fiberglass gutters in period style. The existing addition in the rear remains, but may get a flat roof. Replace 1 over 1 and 2 over 2 windows with 6 over 6 windows. Use Hardiplank or similar siding on additions. Replace rotted woodwork, doors, etc. Remove window in line with chimney and stucco. Replace two double-hung windows on east side with single 7x4 pane window. Replace shutters with new copies. The committee concluded that there is not a lot of the original fabric of the house left and the additions were sympathetic with what is there.
