The following are the Minutes of a Regular Meeting of the Lawrence Township Council that was held on Tuesday, May 3, 2022 at 6:30 p.m.

STATEMENT OF PROPER NOTICE: "Adequate notice of this meeting of the Lawrence Council being held on Tuesday, May 3, 2022, has been provided through the posting of the annual meeting schedule of said Council in accordance with Section 13 of the Open Public Meetings Act." Said Notice was forwarded to the Trentonian, The Times and The Ledger on December 22, 2021.

The meeting was opened with the Inspiration led by the Municipal Clerk and the Pledge of Allegiance led by The Girl Scouts.

The roll was then called as follows:

Present: Council Members Bobbitt, Kownacki, Lewis and Mayor Ryan

Absent: Councilman Powers

Also, in attendance was Kevin Nerwinski, Municipal Manager, and David Roskos, Municipal Attorney.

Special Proclamations, Recognitions and Presentations.

Councilwoman Lewis stated that over the last several years there have been people who do something great and can we recognize them. We have volunteers who have been doing great things in the Community through organized groups or who wanted to help their community. So last year, it was presented to do a Volunteer Award which are broken into several categories and will be done on a quarterly basis. Councilwoman Lewis wanted to thank the Township Manager, who supported the request, to Nancy Bergen in the Recreation Department who started the program and Craig Dinwoodie who has moved in and gotten the ball running.

Councilman Lewis provided a brief background history of each of the recipients, congratulated the honorees and presented the following designated Volunteer Awards:

Victor Gutierrez – Adult Category

William Agress – Lifetime Achievement Award

Lawrence Township Recreation Advisory Committee – Large Group

Public Participation (5-minute limitation per speaker)

Mr. Fred Vereen, 26 Fred Vereen Road, stated he was representing the Lawrence Township Reparation Task Force and the purpose is to have Council affirm and establish a task force for reparation. The Reparation Task Force will prepare a study and a development reparation proposal for African Americans in New Jersey. The Task Force will consist of 11 members (4 Legislatures and 7 public members). There will be six public meetings; a report will be issued no later than 6 months with a final report to the Governor and Legislature. Lawrence Township would be the first Municipality to confirm this legislation. Therefore, Mr. Vereen asked the Council to pass a resolution in support the Reparation Task Force.

Mr. Samuel Frisby, Mercer County Commissioner of 10 Belmont Circle, Trenton, New Jersey, stated he supports the Reparation Task Force. There have been struggles for African Americans as it relates to their skin color, youth incarceration and housing opportunities. He further discussed segregated school districts in the nation, which relates back to economic disparity.

Ms. Nicole Platt, 32 Pine Knoll Drive, stated she is the Co-chair of League of Women Voters and they support the New Jersey Reparations Task Force, which is designed to study and develop reparation proposals for African Americans over a two-year period.

Review and Revision of the Agenda

The Municipal Clerk requested that the Agenda be amended to remove Resolution 178-22 (18.H.1), Authorizing an Appointment to the Public Safety Committee, so the credentials of the applicant can be reviewed.

On a motion by Mr. Bobbitt, seconded by Councilwoman Lewis, the Agenda was amended to include the above revision.

Ordinance No. 2425–22

AN ORDINANCE AMENDING ORDINANCE NO. – 2416-22
SALARY ORDINANCE OF THE TOWNSHIP OF LAWRENCE – UNCLASSIFIED AND/OR EXEMPT, SEASONAL, EMERGENCY (NON-UNION) EMPLOYEES FOR 2022-2023

BE IT ORDAINED by the Township Council of the Township of Lawrence, County of Mercer, State of New Jersey, as follows:

#### Section I. Short Title

This ordinance shall be known and may be recited as "The Salary Ordinance of the Township of Lawrence – Unclassified and/or Exempt, Seasonal, Emergency (non-union) Employees for 2022-2023."

## Section II. Salaried Employees

The attached list of salaried positions and job titles, Schedule A and Schedule B, are hereby authorized and assigned the appropriate salary ranges for 2022-2023 and are determined by date of hire as an employee of Lawrence Township. This ordinance will continue the Township's consistent policy of providing comparable fringe benefits to exempt employees during their active service as that provided to Supervisors, CWA Local 1032, through their collective bargaining agreement. The Township will still maintain the flexibility of granting retiree benefits to exempt employees hired after January 1, 2011. Accordingly, employees covered by this ordinance that are eligible for health and/or prescription benefits shall contribute to the cost of the said health benefit premium for medical and prescription coverage as required by law, specifically Chapter 78, P.L. 2011. All employees hired on or after January 1, 2014 shall contribute based upon the year four rates specified by said law and to be made an Appendix to a successor Agreement.

## Section III. Part-Time or Seasonal Employees

The following part-time or seasonal positions and job titles are hereby authorized and assigned the following pay maximums commencing January 1, 2022 and January 1, 2023:

## Section IV. Eligibility

The ranges in Section II of this ordinance shall pertain to individuals employed by the Township of Lawrence on or after the effective date of this ordinance.

## Section V. Longevity

A. Each employee hired before January 1, 2013 and covered by this agreement shall in addition to his/her regular wages and benefits, be paid longevity based upon years of service as of December 31, 2013 with the Township in accordance with the following amounts. Said amounts to be paid to an employee shall not be adjusted beyond the longevity amount being received by an eligible employee as of December 31, 2013. Longevity shall be pensionable and included as part of the employee's regular pay. Any employee hired on or after January 1, 2014 shall not be eligible to receive longevity pay at any time in the future.

#### Section VI. Other Personnel and Working Conditions

All other functions, responsibilities and rights not specifically enumerated in prior sections of this ordinance shall be judged to be within the province of management, subject only to the laws, rules and regulations of the New Jersey Department of Personnel, the provisions contained in applicable agreements (if any) or policy manuals, and by the issuance of Administrative Directives by the Municipal Manager.

#### Section VII. Repealer

All other ordinances or parts of ordinances adopted prior to the date of this ordinance that are inconsistent with the provisions of this ordinance, are hereby repealed insofar as they relate to or concern the job classifications, salaries and benefits listed in this ordinance.

## Section VIII. Severability

If any section, paragraph, sentence, clause, or phrase of this ordinance shall be declared invalid for any reason, the remaining portions of said ordinance shall not be affected thereby and shall remain in full force and effect.

#### Section IX. Effective Date

- A. This ordinance shall take effect immediately after final adoption as provided by law.
- All salary or compensation provided for and by this ordinance shall be effective the first day of January.
