Jules Rauch, 1010 New York Avenue – Mr. Rauch raises concern over electric bikes, and would like to see helmet regulations amended to 21 years of age. Mr. Rauch suggests adding regulation on where electric bikes and e-scooters can and cannot access. Mr. Rauch states concerns over the workforce housing ordinance.

Martin VanWalsum, 325 Congress Street – Mr. VanWalsum would like to see Ordinance 582-2025 encompass all make and models of electric bikes.

Roz Johnson, 806 Lafayette Street – Ms. Johnson recommends educating employers so employees that utilize e-bikes can be informed of their rules and regulations.


Motion is made to adjourn by Councilmember Meier with all in favor. The Regular Meeting adjourns at 7:14 PM.




