Jules Rauch, 101 New York Avenue – Mr. Rauch expresses frustration over the enforcement of dogs and bikes in certain public areas of the City. Mr. Rauch would like an update on the mercantile renewals for 2025.

Bob Egler, 5 Jackson Street – Mr. Egler raises a question about the location of the proposed bathroom near Jackson Street on the Washington Street Mall.

Peter Garcia, 705 Kearney Avenue – Mr. Garcia expresses concern over various safety issues he has identified in the City, particularly around Soldiers and Sailors Park.

Stacy Sheehan, 928 Columbia Avenue – Ms. Sheehan would like to see regulation on pools in side yards, in the historic district. Ms. Sheehan expresses concerns over the proposed location of the USS Jacob Jones Memorial, stating that it is unsafe for visitors to stop in that area.

Matt Moser, 1351 Delaware Avenue – Mr. Moser states that he would like to see a zoning change in the village green section of the City, allowing the homes to be built higher.
