

RESOLUTION NO. 1135

A RESOLUTION PROVIDING FOR THE TRANSFERS OF APPROPRIATIONS OF SEVERAL DEPARTMENTS OF THE CITY OF KENDALLVILLE, INDIANA, FOR THE 2025 YEAR, REQUESTED BY THE DEPARTMENT HEADS AND FORWARDED TO THE COMMON COUNCIL FOR THEIR ACTION AND PASSAGE,  
PURSUANT TO I.C. 6-1.1-18-6.

WHEREAS, certain extraordinary conditions have developed since the adoption of the existing annual budget for the year 2025, and it is now necessary to transfer appropriations into different categories than was appropriated in the annual budget for the various functions of the several departments to meet expenses.

SECTION 1. BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF KENDALLVILLE, INDIANA, that for the expenses of the City Government, the following appropriations are hereby transferred and set apart out of funds hereinafter named for the purpose specified, subject to the laws governing the same, such sums herein transferred unless otherwise stipulated by law.
