**ORDINANCE NO \_\_\_\_\_**

**AN ORDINANCE TO AMEND CHAPTER 158, STREETS AND PARKING, OF THE MUNICIPAL CODE OF THE TOWN OF DEWEY BEACH, DELAWARE TO REVISE THE DATES ON WHICH PARKING FEES ARE IN EFFECT.**

**BE IT ENACTED AND ORDAINED**, by the Commissioners of the Town of Dewey Beach, Sussex County, Delaware, in session met, as follows:

**WHEREAS**, the Commissioners of the Town of Dewey Beach find that it is appropriate to amend the dates on which parking fees are in effect to provide an equitable, reasonable and necessary revenue increase for the Town; and

**WHEREAS**, the Commissioners of the Town of Dewey Beach are specifically authorized by Section 23(a)(14) of the Charter of the Town of Dewey Beach, 23 Delaware laws, Chapter 59, to “raise funds by charging a fee to owners of vehicles which are parked in the streets and other areas which are accessible to the public.”

**NOW THEREFORE, BE IT ENACTED AND ORDAINED**, by the Commissioners of the Town of Dewey Beach, Sussex County, Delaware, in session met, as follows:

**Section 1.** Amend §158-4 of the Code of Ordinances as depicted by highlighted insertions, strikeouts, and substitutions depicted below:

- A. No person, ~~during the summer season, as defined in Chapter 1, Article III, and herein below,~~ **from 12:01 a.m. May 1 to 12:00 midnight September 30 of every year,** shall park any vehicle on any unmetered zone of any public right-of-way from the hours of 10:00 a.m. to 5:00 p.m. and 11:00 p.m. to 2:00 a.m. the following each day on Mondays, Tuesdays, and Wednesdays, and from the hours of 10:00 a.m. to 2:00 a.m. the following day on Thursdays, Fridays, Saturdays, and Sundays unless a valid parking permit is appropriately displayed on the vehicle and unless official traffic control signs otherwise permit or regulate.

**Section 2.** Amend §158-9 of the Code of Ordinances as depicted by highlighted insertions, strikeouts, and substitutions depicted below:

- B. Rates and hours of operation.

(1) Parking meters shall be in effect daily ~~during the summer season, as defined in Chapter 1, Article III~~ **from 12:01 a.m. May 1 to 12:00 midnight September 30 of every year,** between the hours of 10:00 a.m. and 5:00 p.m. and 11:00 p.m. and 2:00 a.m. on Mondays, Tuesdays, and Wednesdays, and between the hours of 10:00 a.m. and 2:00 a.m. the following day on Thursdays, Fridays, Saturdays, and Sundays.

**Section 3.** If any provisions of this Ordinance shall be deemed or held to be invalid or unenforceable for any reason whatsoever, then such invalidity or unenforceability shall not affect any other provision of

42 this Ordinance which may be given effect without such invalid or unenforceable provision, and to this  
43 end, the provisions of this Ordinance are hereby declared to be severable.

45 **Section 4.** This Ordinance shall take effect immediately upon its passage by a majority vote of the  
46 Commissioners of the Town of Dewey Beach.
