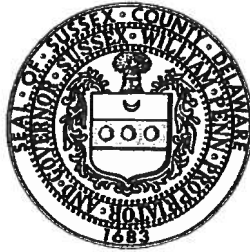

RE: REVENUE SHARING GRANTS FOR FISCAL YEAR 2019

Dear Chief Mackert:

I am pleased to inform you that the Sussex County Council approved the Fiscal Year 2019 Budget with continued funding for local law enforcement grants. This is the fourteenth consecutive year that these grants have been approved in the budget, and similar to the preceding year there are additional grants available to incorporated municipalities without police departments. Municipalities with police departments will be eligible for a grant of \$25,000 to be used for police-related expenditures, and municipalities without a police department will be eligible for a grant of \$12,500 to be used for security-related expenditures.

On June 19, 2018, the budget was approved with no changes to the Revenue Sharing Grant, including the following guidelines:

- Funds are to be used for capital and/or operations expenses related to police or security operations. Items that would not qualify include bonuses, banquets, and promotional items.
- Applications must be signed by the Chief, Mayor, and Town Manager.
 - Applications for security grants would require the signatures of the Mayor and Town Manager.
- Changes of \$500 or more must be submitted in writing and signed by those who signed the initial application.
- Grants would be disbursed without presentation to Council.

Per the original FY 2006 budget terms, this grant was developed to "help offset some costs that local departments experience by assisting the state police outside their municipal jurisdictions." It is the goal of the County Council that the funding be used to help meet the extra demands placed on local law enforcement and security operations. These funds should be used to complement the funds already provided by the municipality's general fund to cover normal day-to-day expenses that are incurred due to police or security-related operations. These funds may be used for the replacement of outdated capital items that are used in the department's daily operations or to purchase capital items which enhance operations. The funds may be used for salary expenses, including budgeted base salaries and overtime. However, the funds may not be used for the payment of bonuses.

As before, each municipality must submit a written application using the provided application form. The application must be signed by the Chief, Town Manager, and Mayor. The application must detail the intended use of the funds. All applications must be submitted via mail to: Sussex County Council, ATTN: Dawn Breasure, P.O. Box 589, Georgetown, DE 19947.

The same application and change requirements apply to municipalities which do not have a police department. However, those applications and change requests require the signature of the Town Manager and Mayor.

The documentation requirements for the grant expenditures remain the same. Documentation, in the form of vendor invoice(s), payroll records, etc., must be submitted within 90 days of receipt of the grant funds. Failure to submit documentation in a timely manner may affect future eligibility, if future grants are awarded.

In order to be eligible for the FY 2019 grant, all documentation must be received for any FY 2018 grant awarded.
