3 **AN ORDINANCE TO REVISE AND AMEND THE ZONING DISTRICT CLASSIFICATION AND**
4 **ACCORDINGLY AMEND THE DEWEY BEACH ZONING MAP REFERRED TO AT CHAPTER 185, SECTION**
5 **185- 6 OF THE MUNICIPAL CODE OF THE TOWN OF DEWEY BEACH, DELAWARE BY CHANGING THE**
6 **EXISTING ZONING DISTRICT DESIGNATION FROM RR, RESORT RESIDENTIAL TO RB-2, RESORT**
7 **BUSINESS FOR A PROPERTY LOCATED AT 26 BELLEVUE STREET, DEWEY BEACH, DELAWARE, TMP**
8 **334-20.18-159.00.**

9 WHEREAS, the Town Council of the Town of Dewey Beach have deemed it desirable to consider the
10 question of whether it is in the public interest to change the zoning district designation for the property
11 located at "26 Bellevue Street" TMP 334-20.18-159.00 from Resort Residential (RR) to Resort Business
12 (RB2) as follows;

13 WHEREAS, Title 22, Chapter 3, Section 301 of the Delaware Code provides that "[f]or the purpose of
14 promoting health, safety, morals or the general welfare of the community, the legislative body of cities
15 and incorporated towns may regulate and restrict the height, number of stories and size of buildings and
16 other structures, percentage of lot that may be occupied, the size of yards, courts and other open
17 spaces, the density of population, and the location and use of buildings, structures and land for trade,
18 industry, residence or other purposes":

19 WHEREAS, Article XV, Chapter 185, Section 73, Changes and Amendments, of the Municipal Code of
20 the Town of Dewey Beach provides that any amendment to the Zoning Ordinance shall be made after a
21 public hearings conducted by both the Planning Commission and the Town Council;

22 WHEREAS, the Planning Commission following a duly noticed public hearing recommended approval
23 of the application to rezone said parcel at their meeting on [insert date];

24 WHEREAS, a public hearing was conducted by Town Council on [INSERT DATE]:

25 WHEREAS, at least fifteen (15) days' notice of such hearing was provided by publishing notice of the
26 time and place of such hearing in an official paper or paper of general circulation in the Town; and

27 WHEREAS, the proposed amendment will promote the health, safety, and general welfare of the
28 Dewey Beach community.

29 BE IT ORDAINED by Town Council, in session met, a quorum pertaining at all times thereto, in the
30 manner following to-wit:

31 Section 1. The Dewey Beach Zoning Map referred to in Chapter 185, Section 185-6 of the Municipal
32 Code of the Town of Dewey Beach, Delaware, be and the same is hereby further amended as follows:

- 33 (A) The property located at "26 Bellevue Street" TMP 334-20.18-159.00 from Residential (RR) in to
34 Resort Business -2 (RB-2); and
35 (B) The zoning classification applicable to said parcel be changed and amended to RB-2

36 Section 2. If any provision of this Ordinance shall be deemed or held to be invalid or unenforceable
37 for any reason whatsoever, then such invalidity or unenforceability shall not affect any other provision

38 of this Ordinance which may be given effect without such invalid or unenforceable provision, and to this
39 end, the provisions of this Ordinance are hereby declared to be severable.

40 Section 3. This Ordinance shall take effect immediately upon its adoption by the Commissioners of
41 the Town of Dewey Beach.
