

**AMENDMENT TO EMERGENCY REGULATION OF THE CAPE  
ELIZABETH TOWN COUNCIL DATED MARCH 25, 2020**

**ORDERED, that the Emergency Regulation: Prohibition on  
Businesses, approved by the Cape Elizabeth Town Council on  
March 25, 2020, is hereby amended as follows; and**

## EMERGENCY REGULATION: PROHIBITIONS ON BUSINESSES

WHEREAS, the Town of Cape Elizabeth hereby declares that a public health emergency necessitating swift action exists in response to the COVID-19 outbreak;

WHEREAS, at this time, guidance from the President of the United States, the Governor of State of Maine, and the Center for Disease Control, urge the public to practice social distancing and not attend events where ten or more people will be gathered;

WHEREAS, said outbreak continues to emerge and spread rapidly, so that the number of cases of COVID-19 in Maine as of ~~this date~~ March 30, 2020, is ~~107275~~;

WHEREAS, health officials have now confirmed ~~66154~~ cases of COVID-19 in Cumberland County with 29 hospitalizations and 3 deaths; and

WHEREAS, the risk of community spread throughout Cumberland County and Cape Elizabeth impacts the life, health and safety of the public and public health is imperiled by the person-to-person spread of COVID-19;

The Town Council of Cape Elizabeth, pursuant to its authority in Article II, Section 12 of the Cape Elizabeth Council-Manager Charter, hereby ~~declare a state of emergency and issue the following regulations, effective March 26, 2020, at 6:00 PM~~ ORDERS:

- ~~1. A civil state of emergency continues to exist within the Town of Cape Elizabeth.~~
- ~~2. All individuals currently living within the Town of Cape Elizabeth are ordered to stay at their place of residence or abode. To the extent individuals are using shared or outdoor spaces, they must at all times as reasonably possible maintain social distancing of at least six (6) feet from any other person with whom they don't share a household~~

when they are outside their residence. All persons may leave their residences only to access COVID-19 Essential Services or as otherwise expressly provided herein. Individuals experiencing homelessness are exempt from this requirement, but are strongly urged to obtain shelter, and be at least six (6) feet from any other person, to the maximum extent practicable and possible.- Individuals seeking relief from domestic violence are exempt from this requirement to the extent that those persons must leave their homes for their personal safety or the safety of their children. Outdoor exercise activities and animal-walking are expressly permitted, provided all persons maintain, to the maximum extent possible, a distance of at least six (6) feet from any other person with whom they do not share a household and abide by the ten (10) person gathering limitation established by the Governor’s Executive Order No. 14 FY 19/20 dated March 18, 2020 entitled “An Order to Protect Public Health,” as may be amended or extended by the Governor from time to time.

3. All persons arriving in the Town of Cape Elizabeth from another state or country and not passing through are ordered to immediately self-quarantine for a period of fourteen days or for the duration of stay, whichever is longer. This self-quarantine requirement shall not apply to public health, public safety, or healthcare workers. Self-quarantine requires that an individual stay in a quarantine location; does not go to work, school or public areas; does not use public transportation; separates from other individuals in a residence as much as possible; and avoids sharing personal items. Individuals self-quarantining under this Order are permitted to leave the quarantine location for a medical emergency or to seek medical care.
4. All travel including, but not limited to, travel on foot, bicycle, scooter, motorcycle, golf carts, automobile, or public transit, for COVID-19 Essential Services is permitted.
5. No auditorium, stadium, arena, large conference room, meeting hall, theater, gymnasium, fitness center, private club, movie theater, museum, dance club, music venue, gymnasium, fitness center, yoga

studio, or indoor cycling studio shall be open while said Proclamation Declaring State of Emergency remains in effect.

**36.** No bar, restaurant, or dine-in facility of any kind or nature shall be open, except as allowed under subsections A and B below, while said Proclamation Declaring State of Emergency, remains in effect.

A. Notwithstanding the above, said bars, restaurants, and facilities may operate in a delivery or “take-out” fashion provided that (1) no customer enters any such restaurant, (2) all transfers of food or other product shall occur either (a) outside of said restaurant or (b) through or at an open window or doorway, and (3) the restaurant takes steps to ensure that no groups of individuals, other than those remaining in motor vehicles, congregate on its premises. Under no condition shall restaurants permit the food provided to be eaten at the site where it is provided, or at any other gathering site on that restaurant’s premises.

B. Schools and other entities that typically provide free food services to students or members of the public may continue to do so under this Regulation on the condition that the food is provided to students or members of the public on a pick-up and takeaway basis only. Schools and other entities that provide food services under this exemption shall not permit the food to be eaten at the site where it is provided, or at any other gathering site on the premises.

**4.7.** No other establishment of any kind that sells or otherwise provides goods or services shall be open while said Proclamation Declaring State of Emergency, and the renewal thereof, remains in effect; except that establishments providing necessary goods and services, as defined in subsection A below, may remain open.

A. Establishments providing necessary goods and services shall include *only* (1) those establishments described in and operating under the restrictions defined in paragraph 3,

subparagraph A, above, and (2) the businesses and organizations listed in the attached Exhibit A.

- Notwithstanding the above, establishments other than those included in subsection A may continue operations consisting exclusively of employees, contractors, or other agents performing activities at their own residences or places of rest.
  - A single employee or agent may be in an establishment closed under this Proclamation in order to perform necessary business functions that do not involve in-person contact with others. No customers or clients may enter the establishment, and no more than one employee or agent may be in the establishment at once.
- B. This Order prohibition includes short-term rentals operated by private property owners. Short-term rentals are hereby declared a non-essential service and shall not continue to operate while said Proclamation Declaring State of Emergency, remains in effect.

8. Fort Williams Park shall be closed to all public motor vehicle traffic. This shall not apply to individuals engaged in services needed to ensure the continuing operation of the government and provide for the public health, safety and welfare, including but not limited to police, fire, EMS, code enforcement, and public works operations, as well as construction. This provision shall also not apply to businesses designated as essential pursuant to Exhibit A that are operating in the park nor to clientele of those businesses.

9. Violation of or failure to comply with this Order is punishable by a fine of \$500.00.

It is hereby encouraged, but not specifically regulated, that all citizens or visitors of the Town of Cape Elizabeth take all necessary steps to care

for themselves and prevent the spread of COVID-19. ~~Such steps include eliminating all unnecessary gatherings, unnecessary travel, and all social events, and remaining at a distance of 6 feet from one another in public spaces, including outdoors. All residents of, temporary residents, and visitors to the Town of Cape Elizabeth are strongly urged to remain in their residence or place of abode except to access COVID-19 essential goods and services, exercise, and dog walking.~~ Such steps will only benefit the health and welfare of the citizens of the Town of Cape Elizabeth and help protect us all. Thank you for all the sacrifices that you have made so far. We look forward to getting through this together.

## **EXHIBIT A**

### Essential Businesses and Organizations

1. Health care operations and pharmacies;
2. Grocery stores, certified farmers' markets, farm and produce stands, supermarkets, food banks, convenience stores, and other establishments engaged in the retail sale of canned food, dry goods, fresh fruits and vegetables, pet supply, fresh meats, fish, and poultry, and any other household consumer products (such as cleaning and personal care products). This includes stores that sell groceries and also sell other non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operation of residences;
3. Food cultivation and processing, including farming, livestock, agriculture, and fishing;
4. Businesses and organizations that provide food, shelter, and social services, and other necessities of life for economically disadvantaged or otherwise needy individuals;
5. Newspapers, television, radio, and other media services;
6. Gas stations and auto-supply, auto-repair, and related facilities;
7. Banks and related financial institutions;
8. Hardware and building material stores;
9. Plumbers, electricians, exterminators, building cleaning and maintenance, and other service providers who provide services that are necessary to maintaining the safety, sanitation, and essential operation of residences and Essential Businesses and Organizations;
10. Businesses and organizations providing mailing and shipping services, including post office boxes;

11. Laundromats, dry cleaners, and laundry service providers;
12. Businesses that manufacture or supply products needed for people to work from home;
13. Businesses that manufacture or supply other essential businesses with the support or supplies necessary to operate;
14. Businesses that ship or deliver groceries, food, goods or services directly to residences;
15. Airlines, taxis, public transportation, and other transportation providers providing transportation services necessary for purposes expressly authorized in this Regulation;
16. Home-based care for seniors, adults, or children;
17. Residential facilities and shelters for seniors, adults, and children;
18. Professional services, such as legal or accounting services, when necessary to assist in compliance with legally mandated activities;
19. Childcare facilities providing services that enable employees of essential businesses and organizations as defined herein to work as permitted. To the extent possible, childcare facilities are recommended to operate under the following conditions:
  - A. Childcare should be carried out in stable groups of 10 or fewer (“stable” means that the same 10 or fewer children are in the same group each day).
  - B. Children should not change from one group to another.
  - C. If more than one group of children is cared for at one facility, each group should be in a separate room. Groups should not mix with each other.
  - D. Childcare providers should remain solely with one group of children.



20. Funeral homes, crematoriums and cemeteries;
21. Animal shelters, veterinary clinics, animal feed and pet supply stores;
22. Government facilities, agencies, and services needed to ensure the continuing operation of the government and provide for the public health, safety and welfare, including but not limited to police, fire, EMS, code enforcement, and public works operations;
23. Businesses and organizations providing for the construction and maintenance of essential infrastructure, including utilities such as electricity, water, wastewater, and telecommunications;
24. Industrial manufacturing facilities;
25. Construction businesses;
26. Insurance businesses;
