Pesticides Discussion

Background

- Comprehensive Plan referrals from the Town Council: Pesticides (#51): "Consider town actions to require residents to minimize pesticide use and take advantage of programs such as the Cumberland County Soil and Water Conservation District (CCSWCD) Healthy Yardscaping initiative."
- At the October 16, 2019 meeting, the Town Council referred to the Ordinance Committee the Comprehensive Plan recommendation regarding pesticides. The Ordinance Committee engaged in an information gathering program over three meetings, as follows:
- May 13, 2020: The committee discussed the purpose of a local ordinance, existing state regulation, what other towns are doing and agreed to pursue a series of speakers to learn about options.
- September 2, 2020: The Ordinance Committee heard a presentation from the Falmouth Conservation Commission Chair about adoption and ongoing implementation of Falmouth's Pesticide Ordinance (adopted in March of 2020).
- September 28, 2020: The Ordinance Committee referred the topic back to the Town Council with the following recommendation: "to send pesticide regulation back to the Town Council for discussion of adopting the Town of Falmouth's approach of tracking community application of pesticides and logging volume before adopting restrictions, and then consider additional steps".
- May 4, 2022: Town Council Meeting: Brief discussion and Request for additional information with regards to other municipalities and their work to date.
