**Action Requested:** Consideration approving the purchase of chemicals from Van Diest Supply Company for the Noxious Weeds Department to further treat noxious weeds along county routes.

Analysis: The Noxious Weeds Coordinator has nearly utilized all of the previously purchased chemicals for noxious weed applications. Due to the extensive number of noxious weeds present along county routes, the Noxious Weeds Coordinator requests additional funds to purchase more chemicals to continue treatment applications this season. This purchase would exceed the budget for chemical purchase though funds are available through reprioritization.
