### **Cowley County Commissioners:**

The Kansas Department of Corrections (KDOC) requires that any fund transfers exceeding \$5,000.00 receive approval from the Board of County Commissioners.

In September, the fiscal department announced a change in the reporting structure for Juvenile Services. Agencies were instructed to consolidate fiscal reporting for the Case Management and Juvenile Intensive Supervision Program (JISP) into the JISP category. This change has resulted in the JISP program appearing over budget.

Upon contacting KDOC's fiscal department for clarification and an update to the reporting workbook, I was advised that the appropriate remedy would be to move the funds accordingly.

Therefore, I am requesting approval for the following fund transfers as detailed in the attached 4th Quarter Budget Adjustment Report:

#### 1. Graduated Sanctions Workbook

Approval to move funds totaling \$31,579.86 from Case Management to Juvenile Intensive Supervision Program (JISP) within the workbook to reflect accurate program expenditures.

### 2. IIP, JIAS, and JISP Programs

- a. Transfer **\$22,187.53** from *Personnel Benefits* to *Equipment* to fund the door project approved on **June 3, 2025**.
- b. Transfer \$1,000.00 from Personnel Benefits to Vehicle Purchase.

#### 3. Community Corrections Grant

- a. Transfer \$10,886.07 from *Personnel Non-Admin Salary* to *Equipment* for the door project approved on **June 3, 2025**.
- b. Transfer \$1,000.00 from Personnel Non-Admin Salary to Vehicle Purchase.
- c. Transfer \$416.82 from Personnel Non-Admin Salary to Utilities.

Your approval of these internal fund movements is respectfully requested in accordance with KDOC guidelines and to ensure accurate fiscal reporting and compliance.
