WHEREAS, the Board of County Commissioners as informed and believes that a certain county township road has described below is used only occasionally or is used only by a few individuals and that proceedings to declare the same as "Minimum Maintenance Road" should be commenced.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF COWLEY COUNTY, KANSAS:

1. That proceedings shall commence pursuant to K.S.A. 68-5,102 to determine whether the following described Cowley County township road should be declared as a "minimum maintenance" to-wit:
