President Tunis opened the meeting and led the Pledge of Allegiance, followed by a moment of silence.

#### Roll Call:

Also present: The Honorable Mayor Ed Brown, Chief Administrative Officer Crandall Jones via Zoom, Solicitor Clarke, Solicitor Youngblood, Chief Municipal Clerk Kate Doggett, Lt. Garay, and Officer Bateman.

## **Rules for Meeting Decorum**

"Upper Darby residents have the opportunity to speak for three (3) minutes. Residents are prohibited from making threats, using profanity, or acting in a manner that would impede or prevent the conduct of the business of the meeting. Any person who attends the meeting and makes remarks, disrupts, or otherwise impedes the orderly conduct of the meeting after receiving a verbal warning may be required to leave the meeting at the discretion of the Council President."

Public Forum should not exceed thirty (30 minutes. If a resident chooses to ask questions, they are voluntarily giving up their time for a response. This means that the 3-minute timer will continue to run no matter who is speaking. The timer will be clearly displayed on the screen.

### **Public Forum**

Shellie Hoyt thanked several individuals for assisting with providing the trash schedule and repairing the streets, and requested that Delco Alerts be used more often. She aired grievances against the administration and discussed the condition of township properties. She inquired why Delco Dispatch does not report when STAT is called.

John Vizzarri of 535 Kirks Lane gave a timeline and communications history on Ordinances 3185 and 3189 and asked for proof that Keystone reviewed Ordinance 3185. He stated that the

Administrative Code requires a year-to-date budget vs. actual figures to be provided quarterly to the Council and the public.

Kyle McIntyre of 1040 Drexel Avenue thanked the township and various departments for assisting with the Delaware County Pride Festival. He noted that the pedestrian signal is knocked over at Baltimore Pike and Union Avenue and said one more mural is scheduled this year at Sellers Recreational Field.

Olivia Taylor, address not provided, spoke about the election of the Vice President of Council at a previous meeting and aired grievances against the council and the administration.

Becky Duggan, address not provided, yielded her time to John DeMasi, who spoke about his Right-to-Know requests and the Office of Open Records determinations. He also addressed expenses invoiced by the Kilkenny firm and paid by the Township.

Joanne Nammavong, address not provided, yielded her time to John DeMasi, who spoke about expenses invoiced by the solicitor and paid by the Township.

Judy Duggan, address not provided, yielded her time to John DeMasi, who spoke about the Home Rule Charter's provisions regarding unauthorized expenses and aired grievances against CAO Jones.

John DeMasi, 706 Stanbridge Road, urged the Council to investigate various issues he proposed. Justine Mays, address not provided, spoke about the code violations she was issued.

Richard A. Blye, address not provided, discussed Juneteenth celebrations and expressed interest in partnering with the Township on future events.

Robert Yantorno of Drexel Avenue stated he is running for the 3rd District Council seat and discussed Upper Darby Township's current financial situation.

Hunter Montgomery, address not provided, highlighted numerous benefits and services provided by the township libraries and advocated for higher wages for library employees.

Resolution No. 23-25 amends the Community Development Block Grant Program Action Plan for Program Year 48 changing the activity of the project entitled "Upper Darby Arts & Education Foundation" from "provision of a dance studio for low and low/mod and special needs families" to "provision of scholarships to low and low/mod and special needs families to participate in arts programs at the Upper Darby Cultural Arts & Education Center".

### President of Council, Hafiz Tunis, Jr.

President Tunis thanked the administration for honoring his request to keep the agenda brief due to scheduled fireworks. He expressed that America is the greatest country and emphasized that all citizens are blessed and should feel grateful to live here.

DB addressed statements made at a previous meeting where he felt his African heritage was attacked and racial comments were made. He does not feel this has a place in Upper Darby, which calls itself "The World in One Place," and asked President Tunis to address it if it happens in the future.
