Council Committee Meeting Minutes

President Tunis opened the meeting and led the Pledge of Allegiance, followed by a moment of silence.

### Roll Call:

Present: Michelle Billups (MB) via Zoom, Marion Minick (MM) via Zoom, Meaghan Wagner (MW), Hafiz Tunis (HT), David Bantoe (DB), Brian Andruszko (BA), Laura Wentz (LW) via Zoom, Matt Silva (MS) via Zoom, Danyelle Blackwell (Dblackwell), and Myron McNeely (Mmcneely).

Excused: Jess Branas (JB).

Also present: The Honorable Mayor Ed Brown via Zoom, Chief Administrative Officer Crandall Jones via Zoom, Solicitors Gallagher and Youngblood, Chief Municipal Clerk Kate Doggett, and Upper Darby Township police officers.

### **Rules for Meeting Decorum**

"Upper Darby residents have the opportunity to speak for three (3) minutes. Residents are prohibited from making threats, using profanity, or acting in a manner that would impede or prevent the conduct of the business of the meeting. Any person who attends the meeting and makes remarks, disrupts, or otherwise impedes the orderly conduct of the meeting after receiving a verbal warning may be required to leave the meeting at the discretion of the Council President."

Public Forum should not exceed thirty (30 minutes. If a resident chooses to ask questions, they are voluntarily giving up their time for a response. This means that the 3-minute timer will continue to run no matter who is speaking. The timer will be clearly displayed on the screen.

### **Public Forum**

Terry Bradley raised concerns regarding the nuisance provisions of the Property Maintenance Code, specifically citing public safety issues related to hazardous trees, and requested that Council address these issues.

Jean Kosha of 7216 Brent Road spoke about losing library employees due to budget constraints and urged the Council to provide adequate funding. She announced that the Teen Advisory Board will host the Fall Festival on October 25, 2025, from 2 to 4 p.m. at the Municipal Branch. She also

expressed support for preserving the green space across from Drexeline. She requested additional lighting at the intersection of Walnut and Shelbourne and asked that parking near the mosque on Garrett Road be addressed to improve safety.

Connie Komm opined on national issues, political parties and their policies, and expressed her views on who she holds responsible for current problems.

Becky Duggan thanked the police for their work during drop-off at Highland Park Elementary School. She inquired about the lease agreement and its purpose outlined in Ordinance 3192. Stephen Komm opined on national issues, political parties, and their policies.

Olivia Taylor complained about public speakers commenting on national issues and council members.

Lee Jordan of 90 Pilgram Lane thanked the group of residents who cleaned up the area of Veterans' Memorial Circle, also known as Dermond Circle. She requested that the Pilgram Garden Civic Association be permitted to take over the maintenance of this circle. She provided an update on the Mozino property carwash proposal.

Terri McGrath of 5018 Sylvia Road spoke about the installation of a "No Parking Anytime" sign on her street, which creates a hardship for her family. She requested that it be removed and believes a disgruntled neighbor created this situation.

Richard A. Blye discussed freedom of speech, racism, and the importance of supporting the police.

Joanne Nammavong requested information on the proposed Shade Tree Commission appointee in Resolution 29-25 and a response to a previously sent email regarding parking enforcement in Municipal Lot #1 during Council meetings.

Justine Mays stated that speakers are not required to provide their addresses during the Public Forum. She discussed a vote to extend the Public Forum from a previous meeting and the earned income tax.

Bob Yantorno inquired about the ongoing negotiations with the FOP and whether the Minimum Municipal Obligation for the pension plan had been met. He invited the public to meet the candidates running for office tomorrow evening from 6:00 to 8:00 PM at Hanrahan's.

Ordinance No. 3192: Parking Lease Agreement with Blue Devil Realty, LLC

Police Superintendent Bernhardt introduced Ordinance No. 3192, establishing a partnership with Blue Devil Realty, LLC, through a lease agreement to install electronic parking meters on the property located at Artillery Brewing, 4221 Ferne Boulevard, Drexel Hill. The presentation included information on revenue sharing, professional services, benefits to the township, and the collaboration with Blue Devil Realty.

Motion to Introduce and Advertise Ordinance No. 3192, Parking Lease Agreement with Blue Devil Realty, LLC, to be voted on at the October 15, 2025 Council meeting.

MW spoke about the parking issue in the area and supports this Ordinance. She clarified that the Blue Devil Realty signs would be replaced with township signs.

LW asked if kiosks that accept cash/quarters would be installed and who owns the property. Superintendent Bernhardt clarified that the township is not leasing the property from Blue Devil Realty, but rather it is a revenue-sharing agreement with Blue Devil Realty.
