

ORDINANCE NO. 3193

AN ORDINANCE OF THE TOWNSHIP OF UPPER DARBY, COUNTY OF DELAWARE, AND THE COMMONWEALTH OF PENNSYLVANIA, APPROPRIATING SPECIFIC SUMS FOR THE PURPOSES OF MUNICIPAL GOVERNMENT IN UPPER DARBY TOWNSHIP FOR 2026

WHEREAS, pursuant to Section 902 of the Home Rule Charter of the Township of Upper Darby, the Upper Darby Township Mayor submitted to Township Council of Upper Darby ("Council") a proposed budget and accompanying message for fiscal year 2026; and

WHEREAS, the proposed budget provides a complete financial plan for Upper Darby Township ("Township") funds and activities for the ensuing fiscal year; and

WHEREAS, pursuant to Section 906(A) of the Home Rule Charter, Council published a general summary of the proposed budget and notice stating the times and places where copies of the proposed budget and budget message were available for inspection by the public; and

WHEREAS, two (2) public hearings were held on the proposed fiscal year 2026 budget on November 5, 2025 and November 19, 2025; and

WHEREAS, following public hearings and after due consideration, the proposed budget was adopted by Council by Resolution No. 40-25; and

WHEREAS, pursuant to Section C-906(C) of the Home Rule Charter, upon approving the budget, Council shall adopt an appropriation ordinance; and

WHEREAS, Council now desires to adopt the appropriations ordinance required by the Home Rule Charter.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Township of Upper Darby, as follows:

SECTION 1. That the following appropriations of specific sums for the purpose of municipal government for Upper Darby Township for the fiscal year 2026 are approved and appropriated:


SECTION 2. If any section, sentence, clause, or word of this Ordinance shall be declared illegal, invalid, or unconstitutional by any Court of competent jurisdiction, such declaration shall not prevent, preclude or otherwise foreclose the validity of the remaining portions of this Ordinance.

SECTION 3. All ordinances or parts thereof inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed.

SECTION 4. Pursuant to the Upper Darby Home Rule Charter, this Ordinance shall become effective immediately upon the signature of the Mayor or, in the event the Mayor neither approves nor vetoes this Resolution, fifteen days after the last day on which the Mayor can approve or veto this Resolution, as set forth in the Upper Darby Township Home Rule Charter, Section C-702.C.


