RESOLUTION NO. 6-25

A RESOLUTION OF UPPER DARBY TOWNSHIP, DELAWARE COUNTY, PENNSYLVANIA APPOINTING CGBAG LAW AS LEGAL OFFICER OF THE TOWNSHIP; REPEALING ALL INCONSISTENT RESOLUTIONS OR PARTS THEREOF; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Upper Darby Township Code, Article VIII, Section 803 (F) provides that there shall be a legal officer of the Township, appointed by the Mayor with the approval of six members of Council, who shall serve as chief legal advisor to the Council, the Mayor, the Chief Administrative Officer, and all Township departments, offices, and agencies and shall represent the Township in all legal proceedings and shall perform any other duties prescribed by this Charter or by law; and,

WHEREAS, the Mayor has determined that CGBAG Law is qualified to serve as the Legal Officer of the Township; and,

WHEREAS, the Mayor now desires to appoint CGBAG Law to serve as the Legal Officer of the Township; and,

WHEREAS, Township Council believes it to be in the best interest of the Township to approve the appointment of CGBAG Law to serve as the Legal Officer of the Township; and,

WHEREAS, Township Council desires to approve the appointment of CGBAG Law to serve as the Legal Officer of the Township.

NOW, THEREFORE, be it, and it is hereby **RESOLVED** by Upper Darby Township Council, and it is hereby **ADOPTED** and **RESOLVED** by authority of same as follows:

- I. CGBAG Law is hereby approved to serve as the Legal Officer of the Township.
- II. All resolutions, or parts thereof, inconsistent with the provisions of this Resolution are hereby repealed to the extent of the inconsistency.
- III. The provisions of this Resolution are declared to be severable. If any provision of this Resolution is declared by a court of competent jurisdiction to be invalid or unconstitutional, such determination shall have no effect on the remaining provisions of this Resolution or on the Upper Darby Township Fee Schedule.
- IV. This Resolution shall be effective immediately.
