**A RESOLUTION OF UPPER DARBY TOWNSHIP, DELAWARE COUNTY, PENNSYLVANIA,  
TO UPDATE AND AMEND UPPER DARBY TOWNSHIP RESOLUTION 34-24,  
AUTHORIZING APPLICATION FOR THE STATEWIDE LSA GRANT FOR THE  
GARRETTFORD BUSINESS DISTRICT; REPEALING ALL INCONSISTENT RESOLUTIONS  
OR PARTS THEREOF, PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN  
EFFECTIVE DATE**

**WHEREAS**, Upper Darby Township, Delaware County, Pennsylvania (“Township”) will be undertaking a project under the Statewide LSA Grant program for the Garrettford Business District (“Project”); and

**WHEREAS**, the Township wishes to participate in said project; and

**WHEREAS**, the Pennsylvania Department of Community and Economic Development makes grants-in-aid to such projects through the Statewide LSA Grant Program; and

**WHEREAS**, on November 20, 2024, the Council of Upper Darby Township (“Council”) approved Resolution 34-24, authorizing the Chief Administrative Officer, or his designee, to make application for the Statewide LSA Grant on behalf of the Township; and

**WHEREAS**, Resolution 34-24 did not set forth the amount of the LSA Grant that the Township was requesting; and

**WHEREAS**, the Township intends to request \$499,106.50 in LSA Grant funds for the Project; and

**WHEREAS**, Council desires to update and amend Resolution 34-24 to include the funding request.

**NOW THEREFORE, BE IT RESOLVED** by the Upper Darby Township Council, and it is hereby **ADOPTED** and **RESOLVED** by authority of same as follows:

1. Resolution 34-24 is hereby updated and amended as follows:

- a. To amend the second “WHEREAS” clause as follows, with the underlined text indicating the added portion of the Resolution: “**WHEREAS**, The Township wishes to participate in said project, and intends to request \$499,106.50 in LSA Grant funding; and”

- b. To amend SECTION I as follows, with the underlined text indicating the added portion of the Resolution: Upper Darby Township Council hereby authorizes the Chief Administrative Officer, or his designee, to make application for the Statewide LSA Grant on behalf of the Township in the amount of \$499,106.50.”
  - c. All other provisions of Resolution 34-24 are affirmed and shall remain in full force and effect.
- 2. All resolutions, or parts thereof, inconsistent with the provisions of this Resolution are hereby repealed to the extent of the inconsistency.
  - 3. The provisions of this Resolution are declared to be severable. If any provision of this Resolution is declared by a court of competent jurisdiction to be invalid or unconstitutional, such determination shall have no effect on the remaining provisions of this Resolution.
  - 4. This Resolution shall become effective immediately upon the signature of the Mayor or, in the event the Mayor neither approves nor vetoes this Resolution, fifteen days after the last day on which the Mayor can approve or veto this Resolution, as set forth in the Upper Darby Township Home Rule Charter, Section C-702.C.
