**A RESOLUTION OF THE TOWNSHIP COUNCIL OF UPPER DARBY TOWNSHIP,
DELAWARE COUNTY, PENNSYLVANIA, APPOINTING
BOARD MEMBERS TO THE UPPER DARBY TOWNSHIP
ZONING HEARING BOARD**

WHEREAS, Upper Darby Township (“Township”) is a Home Rule municipality organized and operating in accordance with the Charter of Upper Darby Township (“Charter”) as permitted by the Home Rule Charter and Optional Plans Law, 53 Pa. C.S. §2901 et seq. (“Home Rule Law”); and

WHEREAS, the Upper Darby Township Code (“Code”) has established the Upper Darby Township Zoning Hearing Board, providing for its membership, Board functions and powers, Code, at §550-54

WHEREAS, the Charter provides that the Mayor shall appoint all members of authorities, boards, and commissions, with the approval of six members of Council, Charter at C-403.J; and

WHEREAS, after review of his application for same, the Mayor desires to re-appoint Steve Bertil to the Zoning Hearing Board for a three year term beginning January 1, 2026 and expiring December 31, 2028; and

WHEREAS, after review of his application for same, the Mayor desires to appoint Alfonso Zamora to the Zoning Hearing Board to fill the remainder of an unexpired term, through December 31, 2027; and

WHEREAS, Township Council believes it to be in the best interest of the Township to approve the re-appointment of Steve Bertil and the appointment of Alfonso Zamora to the Zoning Hearing Board.

NOW THEREFORE, BE IT RESOLVED by the Upper Darby Township Council, and it is hereby **ADOPTED** and **RESOLVED** by authority of same as follows:

1. Steve Bertil is hereby appointed to serve on the Upper Darby Township Zoning Hearing Board for a term commencing January 1, 2026 and ending December 31, 2028.
2. Alfonso Zamora is hereby appointed to serve on the Upper Darby Township Zoning Hearing Board to fill the remainder of an unexpired term ending December 31, 2027.

3. All resolutions, or parts thereof, inconsistent with the provisions of this Resolution are hereby repealed to the extent of the inconsistency.
4. The provisions of this Resolution are declared to be severable. If any provision of this Resolution is declared by a court of competent jurisdiction to be invalid or unconstitutional, such determination shall have no effect on the remaining provisions of this Resolution.
5. This Resolution shall become effective immediately upon the signature of the Mayor or, in the event the Mayor neither approves nor vetoes this Resolution, fifteen days after the last day on which the Mayor can approve or veto this Resolution, as set forth in the Upper Darby Township Home Rule Charter, Section C-702.C.
