**A RESOLUTION AMENDING 27-2025, 2026 ANNUAL APPROPRIATIONS  
AND DECLARING AN EMERGENCY.**

BE IT ORDAINED, BY THE COUNCIL OF THE VILLAGE OF NEWCOMERSTOWN,  
STATE OF OHIO, COUNTY OF TUSCARAWAS AS FOLLOWS:

SECTION #1: THAT 27-2025 OF THE VILLAGE OF NEWCOMERSTOWN, BE AND THE  
SAME IS HEREBY AMENDED TO ADDITIONAL APPROPRIATIONS OF THE  
VILLAGE OF NEWCOMERSTOWN AS FOLLOWS:

SECTION #2: ALL RESOLUTIONS OR PARTS OF ORDINANCES/RESOLUTIONS IN  
CONFLICT HEREWITH TO THE EXTENT OF SUCH CONFLICT ARE HEREBY REPEALED.

SECTION #3: THIS RESOLUTION IS HEREBY DECLARED TO BE AN EMERGENCY  
MEASURE AND ITS IMMEDIATE PASSAGE IS NECESSARY IN ORDER TO PRESERVE  
PROTECT AND MAINTAIN THE HEALTH, SAFETY AND WELFARE OF THE CITIZENS OF  
NEWCOMERSTOWN, OHIO AND FOR THE FURTHER REASON THAT IN ORDER TO  
MAINTAIN THE EFFICIENT MANAGEMENT OF VILLAGE OF ACCOUNTS, THE FOREGOING  
ADDITIONS OF ACCOUNTS

SECTION #4 WHEREFORE, THE RESOLUTION SHALL TAKE EFFECT AND BE IN  
FORCE IMMEDIATELY UPON ITS PASSAGE AND APPROVAL, PROVIDED IT RECEIVES THE  
AFFIRMATION VOTE OF THREE-FOURTHS OF THE MEMBERS  
ELECTED TO OR APPOINTED TO COUNCIL FROM AND AFTER THE EARLIEST PERIOD  
ALLOWED BY LAW.
