**RESOLUTION APPROVING AND ADOPTING A LOCAL LAW  
OVERRIDING THE TAX LEVY LIMIT  
ESTABLISHED BY GENERAL MUNICIPAL LAW § 3-c  
FOR THE 2026–2027 FISCAL YEAR**

At a meeting of the Village of Spring Valley Board of Trustees held on the 29th day of April 2026, at the Village Hall in said Village, \_\_\_\_\_ moved the adoption of the following resolution and \_\_\_\_\_ seconded.

**WHEREAS**, General Municipal Law § 3-c establishes a limitation on the amount by which the real property tax levy of a local government may be increased from one fiscal year to the next; and

**WHEREAS**, General Municipal Law § 3-c(5) authorizes a local government to override such tax levy limitation for a particular fiscal year by adoption of a local law approved by the affirmative vote of at least sixty percent (60%) of the governing body; and

**WHEREAS**, the Board of Trustees of the Village of Spring Valley has determined that it is necessary and in the best interests of the Village to adopt a local law overriding the tax levy limit for the fiscal year commencing June 1, 2026 and ending May 31, 2027; and

**WHEREAS**, a duly noticed public hearing on the proposed local law was held on April 29, 2026 at 8:15 p.m., at which time all interested persons were given an opportunity to be heard;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of the Village of Spring Valley, County of Rockland, State of New York, as follows:

**Section 1. Approval and Adoption of Local Law.**

The Local Law entitled “A Local Law to Override the Tax Levy Limit Established in General Municipal Law § 3-c for the 2026–2027 Fiscal Year” is hereby approved and adopted.

**Section 2. Authorization to File.**

The Village Clerk is hereby authorized and directed to file the adopted Local Law with the New York State Secretary of State in accordance with the Municipal Home Rule Law.

**Section 3. Effective Date.**

This resolution shall take effect immediately upon adoption, and the Local Law shall take effect upon filing with the Secretary of State.

At a meeting of the Village of Spring Valley Board of Trustees held on the 29th day of April 2026, at the Village Hall in said Village, \_\_\_\_\_ moved the adoption of the following resolution and \_\_\_\_\_ seconded.

**WHEREAS**, Village Law § 5-508 requires the Board of Trustees of the Village of Spring Valley to prepare and adopt a tentative budget for the ensuing fiscal year; and

**WHEREAS**, the Mayor of the Village of Spring Valley has prepared and submitted to the Board of Trustees a proposed budget for the fiscal year commencing June 1, 2026 and ending May 31, 2027; and

**WHEREAS**, the Board of Trustees has reviewed said proposed budget; and

**WHEREAS**, a duly noticed public hearing on the proposed budget was held on April 29, 2026 at 8:15 p.m., at which time all interested persons were afforded an opportunity to be heard;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of the Village of Spring Valley, County of Rockland, State of New York, as follows:

**Section 1. Adoption of Tentative Budget.** The proposed budget for the Village fiscal year commencing June 1, 2026, and ending May 31, 2027, as presented by the Mayor and as considered by the Board of Trustees, is hereby adopted as the Tentative Budget of the Village of Spring Valley.

**Section 2. Authority to Amend Prior to Final Adoption.** The Board of Trustees expressly reserves the right to amend the Tentative Budget prior to the adoption of a Final Budget, as permitted under Village Law § 5-508.

**Section 3. Effective Date.** This resolution shall take effect immediately.

At a meeting of the Village of Spring Valley Board of Trustees held on the 29th day of April 2026, at the Village Hall in said Village, \_\_\_\_\_ moved the adoption of the following resolution and \_\_\_\_\_ seconded.

**WHEREAS**, Village Law § 5-508 requires the Board of Trustees of the Village of Spring Valley to adopt a final budget for the ensuing fiscal year after a public hearing; and **WHEREAS**, the Mayor of the Village of Spring Valley submitted a proposed budget for the fiscal year commencing June 1, 2026 and ending May 31, 2027; and

**WHEREAS**, the Board of Trustees adopted a Tentative Budget and thereafter caused a duly noticed public hearing to be held on said budget on April 29, 2026 at 8:15 p.m., at which time all persons wishing to be heard were afforded an opportunity to do so; and

**WHEREAS**, the Board of Trustees has considered the comments received at the public hearing and has determined that it is in the best interests of the Village to adopt the budget as the Final Budget for the 2026–2027 fiscal year;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of the Village of Spring Valley, County of Rockland, State of New York, as follows:

**Section 1.** Adoption of Final Budget.

The budget for the Village fiscal year commencing June 1, 2026 and ending May 31, 2027 is hereby adopted as the Final Budget of the Village of Spring Valley.

**Section 2.** Budget on File.

The Final Budget shall be filed with the Village Clerk and shall be available for public inspection during regular business hours.

**Section 3.** Authorization to Implement.

The Mayor, Treasurer, and all Village officers and employees are hereby authorized and directed to take any and all actions necessary to implement the Final Budget as adopted.

**Section 4.** Effective Date.

This resolution shall take effect immediately.
