

"Verizon Wireless") in favor of the Town of Oceanview, Sussex County, Delaware h	aving an address of
201 Central Avenue, Sussex County, Delaware, 19970 (the "Town").	C

BACKGROUND

- A. Verizon Wireless has been authorized by the Federal Communications Commission (the "FCC") to operate a wireless communications system within its designated frequency spectrum in Sussex County, Delaware.
- B. Pursuant to a license granted by the FCC, Verizon Wireless is required to provide wireless service to its customers.
- C. Verizon Wireless must ensure that its wireless signal strength is sufficient to provide proper reception and communication within its licensed area. Currently, in portions of the Town of Oceanview, Sussex County area, there is a very weak signal strength, which results in poor wireless service.
- D. Verizon Wireless's engineers have determined that the installation of a wireless communications facility, which would include a 180' tower (the "Tower"), is necessary to improve signal strength in the Town of Oceanview, Sussex County, Delaware area. The height required for such a communications Tower in order to meet Verizon Wireless's technical needs is 180' above ground elevation. The Tower will have an overall height of 185' factoring in the height of a 5' lightning rod.
- E. In order to better serve the residents of Town of Oceanview and the general public, Verizon Wireless entered into a lease agreement for a 50' x 50' parcel of land owned by Bear Trap Partners, L.L.C. located at 222-245 Maintenance Road, Town of Oceanview, Sussex County, Delaware, said leased parcel having an area of approximately 2,500 sq. ft. (the "Premises"). The Premises is more particularly described in the Tax Map in the County of Sussex, Parcel No.: 134-16.00-289.00
- F. Town of Oceanview Ordinance No.: 140-131 (the "Ordinance") regulates the proposed use of the Premises by Verizon Wireless as a communications facility.
- G. Section 140-132 (9) of the Ordinance requires that all applicants seeking a special exception to construct, erect, relocate or alter a communications facility shall demonstrate compliance with 140-131 on application forms provided by the Town, accompanied by a fee and the following documents: a written agreement to remove the tower and/or antenna within 180 days after cessation of use. ..."

H. Verizon Wireless is agreeable to removing the Tower within one (180) days following the abandonment or cessation of the use of the Tower as a communications facility subject to the terms hereof.

NOW, THEREFORE, in consideration of the covenants and conditions set forth herein, Verizon Wireless, intending to be legally bound, hereby agrees as follows:

- 1. <u>Removal of Tower Upon Cessation or Abandonment of Use</u>. Within a period of 180 days following the abandonment or cessation of the use of the Tower as a communications facility, Verizon Wireless shall remove its buildings, the Tower (except footings), equipment, fixtures and all its personal property from the Premises and shall restore the Premises to its original condition, reasonable wear and tear and casualty damage excepted as required by Section 140-131 (9) of the Ordinance.
- 2. <u>Binding Effect</u>. This Agreement shall bind and inure to the benefit of the heirs, administrators, and assigns of the parties hereto. This Agreement contains the entire Agreement among the parties regarding the transactions described herein. This Agreement shall not be modified without the prior written agreement of Verizon Wireless and the Town of Oceanview. This Agreement shall be binding upon and shall inure to the benefit of Verizon Wireless and the Town of Oceanview and their respective successors and assigns.
- 3. <u>Governing Law.</u> This Agreement shall be governed in accordance with the laws of the Delaware.

IN WITNESS WHEREOF, and intending to be legally bound hereby, Verizon Wireless has executed this Agreement in favor of the Town of Oceanview.
