- Synopsis: This ordinance works in conjunction with a pending ordinance, which proposes to redefine fast food restaurant and add fast food restaurant with drive through and fast food restaurant with drive in to the table of permitted uses, by adding these types of restaurants to the off-street parking requirements chart, and establishing the number of spaces required for each type of fast food restaurant. It also revises the number of spaces required for restaurants, by applying the per square feet multiplier to the area dedicated to patron use only, and including an additional number of spaces based on the number of employees.
