MINUTES of the REGULAR TOWN COUNCIL MEETING 32 WEST AVENUE

September 12, 2023 @ 3:00PM

1. CALL TO ORDER

Mayor Reddington called the meeting to order at 3:00 p.m. with the **Pledge of Allegiance**. <u>Present:</u> Council Members Colleen Twardzik, Don Walsh, Jay Tyminski, and Steve Cobb, Police Chief Ken McLaughlin, Finance Director Dawn Parks, Planning, Zoning & Development Director Ken Cimino, Town Manager Carol Houck, Town Solicitor Veronica Faust, and Town Clerk Donna Schwartz were also present.

2. COMMUNICATIONS AND PRESENTATIONS

The Audit Report for FY24 was presented by Ashley Stern and Alyssa Rebel of PKS. Ms. Stern thanked the staff for their help and cooperation during the recent audit. She noted that they have given the town a rating of an unmodified opinion, the highest level of opinion you can get. Ms. Stern continued to explain other aspects of the audit, citing no internal weaknesses or no non-compliance issues. She stated that the town's internal controls are good, and she sees no significant problems.

Brian Warnock, the Estuary, stated he was legal in Delaware dispensary, many people look like him. He said Medical Marijuana will not wreck the town. It is just a little store. He is forced to go to Maryland to buy his products. Mr. Warnock asked Council to please reconsider.
