MINUTES of the REGULAR TOWN COUNCIL MEETING 32 WEST AVENUE October 10, 2023 @ 3:00PM

1. CALL TO ORDER

Mayor Reddington called the meeting to order at 3:00 p.m. with the **Pledge of Allegiance**. <u>Present:</u> Council Members Colleen Twardzik, Don Walsh, and Steve Cobb, Police Chief Ken McLaughlin, Finance Director Dawn Parks, Planning, Zoning & Development Director Ken Cimino, Town Manager Carol Houck, Town Solicitor Veronica Faust, and Town Clerk Donna Schwartz were also present. Council Member Tyminski was absent.

2. PUBLIC HEARING

Mayor Reddington read a statement regarding the following ordinances. Town Solicitor Faust offered a synopsis for each ordinance below.

A. Discussion, Consideration and Possible Voting on an Ordinance amending the Town of Ocean View Code relating to use Regulations as set out in Chapter 140, Land Use and Development.

Synopsis: The purpose of this ordinance is to prohibit marijuana cultivation facilities, marijuana product manufacturing facilities, marijuana testing facilities, retail marijuana stores or marijuana smoking lounges as a permitted use in any zoning districts within the Town of Ocean View.

Public Comments:

Brian Warnock, the Estuary, stated if they allowed marijuana, it would not bring the boogie man to Ocean View. If you don't allow marijuana, you will be inconveniencing your neighbor. Nothing bad is going to happen to the Town.

<u>Alexandra Miller</u>, West Avenue, commented that marijuana is safer than alcohol. She noted the Ocean View She noted that she also sent emails to the Council Members. Ms. Miller stated cannabis saved her life. She said the benefits to mental health and children from tax dollars are great. Ms. Miller offered to discuss it one on one with Council, or the Chief, if they are interested.

Jene Duffy, Milton, noted that she is with the Cannabis Advocacy Group, and she wants the Council to allow marijuana in the town. She is against the ban in Ocean View, and said cannabis is safer than tobacco and alcohol.

<u>Lizzie Golob</u>, Millsboro, stated she has been opiate free since 2016. She said she is using cannabis edibles instead, which work very well for her. She asked the Council not to ban marijuana, she said it could boost sales of all other businesses in town.

Mayor Reddington noted that the Council received emails from Alexandra Miller and Dawn Lentz.

Brian Warnock noted that he did not see a crowd of people in opposition to the ordinance, so he says the Council should approve the use of cannabis. Council Member Cobb asked

Mr. Warnock why all the towns in Sussex County are against marijuana sales and use. Mr. Warnock answered he did not know the answer, but he thought was just ignorance.

A motion was made by Council Member Cobb, seconded by Council Member Walsh, to approve the ordinance to prohibit marijuana cultivation facilities, marijuana product manufacturing facilities, marijuana testing facilities, retail marijuana stores or marijuana smoking lounges as a permitted use in any zoning districts within the Town of Ocean View. The motion was carried unanimously 4/0.

B. Discussion, Consideration and Possible Voting on an Ordinance amending the Town of Ocean View Code relating to Licenses as set out in Chapter 93.

No Comment from Council or the Public.

<u>Synopsis:</u> The purpose of this ordinance is to prohibit the issuance of licenses to operate various marijuana related businesses in the Town of Ocean View.

No comments from the Council or the public.

A motion was made by Council Member Walsh, seconded by Council Member Twardzik, to pass an Ordinance amending the Town of Ocean View Code relating to marijuana related Licenses as set out in Chapter 93. The motion was carried 4/0.

C. Discussion, Consideration, and Possible Voting on an Ordinance amending the Town of Ocean View Code relating to Property Maintenance as set out in Chapter 169.

<u>Synopsis</u>: This ordinance amends Chapter 169 to include additional and revise established nuisances and to include requirements for building and yard maintenance.

Mr. Cimino offered some explanation to the Council about the ordinance. No Comment from Council or the public.

A motion was made by Council Member Twardzik, seconded by Council Member Cobb, to approve the Ordinance amending the Town of Ocean View Code relating to Property Maintenance as set out in Chapter 169. The motion was carried 4/0.
