# MINUTES of the REGULAR TOWN COUNCIL MEETING 32 WEST AVENUE

September 9, 2025 @ 3:00PM

#### 1. CALL TO ORDER

Mayor Reddington called the meeting to order at 3:00 p.m. with the **Pledge of Allegiance.** *Present*: Council Members Jay Tyminski, Steve Cobb, Don Walsh, & Colleen Twardzik, Town Manager Carol Houck, Finance Director Dawn Parks, Police Chief Ken McLaughlin, Planning, Zoning & Development Director Ken Cimino, Public Works Facility Manager Matthew Martin, Town Solicitor Veronica Faust, and Town Clerk Donna Schwartz. Jim Lober was also present to discuss fast-food ordinances.

Mayor Reddington began the meeting by making corrections to the agenda numbering. He asked for a change to the agenda by moving items 6, 8, and 9 to the top of the meeting agenda due to the large crowd. A motion was made by Council Member Cobb, seconded by Council Member Tyminski to adjust the agenda. The motion carried unanimously 5/0.

#### 2. AUDIT PRESENTATION

The auditors were present to report on their findings of the FY25 Audit. Alyssa Revell and Ashley Stern representing PKS Certified Public Accounting Firm told Council that they have given the town an Unmodified score, the highest rating one can give. They said they found no material weaknesses, overall, the town was under budget on expenditures by \$592,046. They were pleased to share that the town has fully funded pensions. Ms. Revell explained in slight detail the upcoming new accounting pronouncements of GASB 102, 103 and 104, which will be in effect in coming years.

Mayor Reddington questioned whether two months of income coving expenditures were sufficient and what amount is considered the ceiling. Ms. Stern replied that no more than six months was considered the maximum, she said the town is carrying five months of funds. Council Member Cobb questioned whether sick time was a liability.

#### 3. PUBLIC HEARINGS

A. Second Reading of an Ordinance Governing the Disposition of Seized, Forfeited, or Unclaimed Property.

Mrs. Faust explained the need for the ordinance regarding disposal procedures of property. There were no comments from the Council or the public.

A motion was made by Council Member Twardzik, seconded by Council Member Walsh, to approve the ordinance governing the disposition of seized, forfeited, or unclaimed property. The motion carried unanimously 5/0.

B. Second Reading of an Ordinance Amending Chapter 213, Article 1 and Repealing Chapter 213, Articles II & III of the Town of Ocean View Code relating

to the Town of Ocean View Water System and Associated Fees and Charges and Private Wells.

Mrs. Faust explained the need for the amendments to Chapter 213 now that the water sale has been completed. There were no questions from the Council nor the Audience.

A motion was made by Council Member Cobb, seconded by Council Member Twardzik to repeal Chapter 213. The motion carried unanimously 5/0.

C. First Reading of an Ordinance amending Sections 140-26, 140-128, and 140-152, of the Ocean View Land Use and Development Code by defining various Permitted Types of Fast-Food Restaurants, adding them to the Table of Permitted Uses as Special Exceptions in Certain Zoning Districts, adding Development Standards for each, and amending Section 140-121 to add Surgical Centers for renumbering purposes only.

Ms. Faust explained the need for the ordinance to Council, Mr. Lober details some of the highlights of the ordinance, saying in particular that a fast-food restaurant must have its own dumpster, which the Planning and Zoning Commission voted on before recommending to Council.

- D. First Reading of an Ordinance amending Section 140-59-E(1) of the Ocean View Land Use and Development Code by adding Fast-Food Restaurants. Fast-Food Restaurants with Drive Through, Fast-Food Restaurants with Drive-in, as uses to the required Off-Street Parking Spaces Chart, revising the number of Off-Street Parking Spaces Chart required for Restaurants and Establishing the number of Off-Street Parking Spaces required for the aforementioned types of Fast-Food Restaurants. Ms. Faust explained the need for the ordinance to Council, Mr. Lober briefly explained the need for the ordinance.
- E. First Reading of an Ordinance amending Section 140-65 of the Ocean View Land Use and Development Code by adding additional types of pf signs associated with Fast-Food Restaurant with Drive-in to the signs permitted in GB-1 and GB-2 zones. Ms. Faust explained the need for the ordinance to Council, Mr. Lober briefly explained the need for the ordinance.

## 4. ADOPTION of Agenda

A motion was made by Council Member Cobb, seconded by Council Member Tyminski, to adopt the agenda as changed. The motion passed unanimously 5/0.

## 5. APPROVAL of the Town Council Minutes
