## City of Odessa Odessa Planning and Zoning Commission Minutes - April 17, 2025

Call to Order: Matt Modlin, chair, called the meeting to order at 7:00 p.m. following a 6:30 p.m. reception for out-going commissioners Marty McDermed and Ruth Beamer, who were presented a certificate and plaque by Bryan Barner, mayor, recognizing their years of service.

**Roll Call:** Present were Modlin, Marty Bertram, Ruth Beamer, Bill Hunt, Marty McDermed and Jo Ann Quigley, commissioners. Also present were Steve Nance, in-coming commissioner; and Lisa Bailey, Jessica McGinnis and Mike Plachte, visitors. City staff present were Shawna Davis, city administrator; Christi Dickey, community planning and development support staff; and Lindsey Kolisch, attorney.

**Consent Agenda -** On motion by McDermed, seconded by Quigley, minutes of March 20, 2025 were approved unanimously.

**New Business -** Election of a secretary to replace Beamer was held, with Nance accepting the position.

**Work Session -** Beginning at 7:34 p.m., the remainder of the meeting was spent with Davis and Dickey continuing an exercise, begun at the March meeting, seeking commission input on where a list of certain land uses would be best permitted. Davis presented new and extensive information on an additional zoning designation, Planned Unit Development (PUD), with the recommendation that it be considered when continuing the discussion. On motion by McDermed, seconded by Quigley, commissioners voted unanimously to recommend to the Board of Aldermen the addition of PUD to the zoning code.
