# Bill No. 2022-27 (1st reading) – Repealing Salary Compensation Schedule

# Discussion: Bid No. 12-22 - Odessa City Hall Renovations & Additions

Mayor Wright stated that the construction budget for the new city hall was distributed to the Board. Mayor Wright apologized that the bid estimate document was not included in the packet, staff just received it the day of the meeting.

Alderwoman Ehlert questioned the credit for the value engineering of \$50,000. Patrick Smith, Incite Design Studio stated that on Tuesday, December 6<sup>th</sup> the City took bids for the construction cost for the new city hall. He stated that the light gray column on the construction budget sheet is the numbers that were presented earlier in the year, and the bold numbers are the actual bid results from Aquila Industries, the company that was chosen during the bid opening. Patrick Smith stated that there was a slight overage, and he has been working with Aquila to get the numbers closer to the budget.

Alderman Cramer stated that he looked at the subtotal base bid of \$288,959.00 as compared to June's total of \$162,500.00. He went on to say that on the upper end it came in \$70,000 under was estimated, and on the lower end Incite Design missed the ball by \$120,000 +\-. He stated that was a pretty major over swing.

Mr. Smith stated that when his company is estimating they are looking at a number of different things, and parts and pieces are coming from different packages. He stated that there may be times when he is off on one item high or low, but really we are looking at the total number here. Mr. Smith stated that if you add the alternate base bid and when he was here this past summer had contingency inflation numbers too, and if you look at that compare the subtotal, they were at \$885,675.00 back then, and now they are at \$842,891.00 right now. Mr. Smith stated that from a bid result stand point they actual went down. Alderman Cramer stated that, that is true, but it still doesn't answer the question he asked. Alderman Cramer stated that the Board was looking at two different projects, one where we completed the project in its entirety, and the other was enough to just get the building useable as is. That number in June was \$162,500. Mr. Smith stated that was correct, that was his estimate. Alderman Cramer stated now the total is \$28,959.00, that's a substantial miss. Alderman Cramer stated that just using the building as is there was a miss of \$100,000.00. Mr. Smith stated he did miss it. Alderman Cramer stated that he is trying to figure out how this was missed that bad. Mr. Smith stated that he may have not had all the square footages calculated correctly, he missed the mark on some of the materials. He stated that sometimes with these small projects it's hard to anticipate staff work load, on where they are going to come from, who has a need from a construction stand point. He stated that yes, he missed the mark on the summer base bid.

Alderwoman Ehlert asked for an explanation for tier 1, 2 and 3. Mr. Smith stated that was a tool used early on, breaking down 3 different levels of renovations. The lowest cost level being just finished up work, more aesthetics, on the flip end, the higher cost tier gets in to reworking and changing the duct work, adding more offices, updating the mechanical,

electrical, and plumbing systems. Mr. Smith stated that when he was working up the estimate he did it on three different levels. Those numbers have now all been combined. Basically, it's for the bidding process.

Alderwoman Ehlert asked if the soft cost, that includes technology etc., if they did the entire project, if the Board leans to just doing the building as is and get it to where it is usable, and not add the addition, what soft cost are going to apply to just the building without the new addition. Mr. Smith stated that there would be a reduction of about \$40,000 - \$50,000 or so. You could remove the council chamber furniture, you wouldn't need as many security card access. Mr. Smith stated that you could reduce the total cost by roughly \$40,000.

Alderman Cramer asked if the City could sell the building for what they paid for it. Alderman Lockhart stated that he thought they could. Alderman Cramer stated that if there are plans to build a police building down the street, you could build it all in one. Mayor Wright stated that he would disagree, there is not enough room in that location to construct it all.

Alderman Barner stated that when the Board approved the bid for this was with the understanding that the money that was paid for the building \$550,000 would be returned to the general fund. He stated that, that is money that can be used for a lot of different things. He stated that he's not on board with anything that doesn't return funds back into the general fund like what was originally discussed.

Alderwoman Ehlert stated that she has been in the building off and on turning on the holiday music, and she stated that it's a wonderful building. She stated that you could just walk in there and see our City Hall being in that building. Alderwoman Ehlert stated that she is nowhere near the thought of selling the building. There is space to grow in the building. She stated that being a steward of the cities money, she doesn't feel that right now the money should be spent on the new addition, but would love to see city hall move into that building as soon as possible. Alderman Barner agreed with that statement. He stated that he also agrees with Alderman Cramer. He stated that he didn't think it was the right time to add the addition since the Board is going to ask the citizens to help with the build out of a new police / court building, on the north side of the 1912 building. That chamber could be used for the board meetings. Mayor Wright stated that it would need to be used for all of the cities board meetings.

Alderman Cramer stated that he thought the bank building would make a fantastic City Hall, but he is not happy with the numbers presented.

Alderwoman Ehlert stated in the action report if the money was not but back in the general fund the city would still be at 50%. Shawna Davis, Interim City Administrator stated that it would be over 50%. Based on her numbers Fiscal Year ending March 31, 2022, there is a fund balance of 73%. Ms. Davis stated that if the city were not to replenish the \$550.000 taken out plus what was budgeted this fiscal year that would bring it to 58%. If we replenish the \$550.000 then that would raise it 73%.

Alderwoman Ehlert stated that the city has the spillway and new police building coming up and would like to keep the fund balance at 73%. She stated that even though the numbers missed the mark, compared to the other bids, the total is in the same ball park. Mayor Wright stated that the other bids that came in were much higher than the bid the Board is looking at. Alderman Cramer stated that he was surprised that none of the local construction firms bid on the project. Mayor Wright stated that five companies visited on the initial visit, then two others visited, and the four (4) bids were what was submitted.

Alderwoman Starr stated that she disliked phases, and would rather see the project completed in its entirety. Alderman Cramer stated that if the city is going to build a new FEMA shelter and court room, then the addition doesn't need to be completed. The Board meetings can be held in the new building.

Alderman Barner stated that in April the Board is going to ask the citizens of Odessa for a bond to fix the spillway. It will cost the average homeowner over \$100 a year probably to get that done. The Board needs to ensure them that more than fixing the spillway will take place, he stated that the city will need a healthy general fund. He stated that if he was asked to vote for a bond to just fix the spillway, he wouldn't vote for it. Mayor Wright stated that, that is not what the city will be asking. Alderman Barner stated thank you I'm happy to hear that. Mayor Wright stated that the Board is trying to combine all of the city projects into one, and they are all separate issues. Ms. Davis added that when you're talking about fund balance you don't want to think about how you can incorporate the fund balance dollars into your operating budget. When you're spending your fund balance it has to be for a one time purchase. Increasing maintenance, or hire an additional person, you would use the operating budget.

Alderman Cramer stated that there is a \$553.000 difference between the two options.

Motion was made by Alderman Cramer, to proceed with the base bid of \$288,959.00 to get the building ready to be used as a City Hall, minus the soft cost until the numbers are revised, and voted on at a later date. Seconded by Alderman Barner with the caveat that \$550.000 would be returned to the general fund. No Roll Call was conducted, motion failed.

Mayor Wright stated that he actually needs a vote to either accept or deny the bid for Aquila Industries as the cities general contractor.

Ms. Davis stated that entire \$550.000 and the money from the sale of the old city hall would be returned to the general fund.

Amended motion was made by Alderman Cramer, to proceed with the bid from Aquila Industries with the base bid of \$288,959.00, with a caveat that the entire \$550,000.00 be returned to the general fund, seconded by Alderman Barner.

Ms. Davis stated that the entire \$550.000 and the money from the sale of the old city hall would be returned to the general fund.
