## 2g) South Onondaga Fire Department

**Town Councilor Mary Ryan** said that being a lifelong resident of South Onondaga, she has deep ties with the South Onondaga Fire Department. She said she was good friends with Tim Nelson's older brother, and good friends with Susan Fisher's husband, Doug. Councilor Ryan said she and Sue have worked together to move the Norton Road/Bussey Road water district forward, and work toward grants for the district. South Onondaga has had a water district for 25 years, which was one of the first major projects Ms. Ryan worked on as a town councilor. Councilor Ryan said that Don Fisher worked with her and others, including Ron Ryan, to create the water district for hundreds of Town residents in the southern area of the Town of Onondaga.

Councilor Ryan said her father was a member of the South Onondaga Fire Department for 63 years, and that all of the members do a wonderful job protecting the district. Knowing there is a flooding issue in South Onondaga along the west branch of Onondaga Creek, Doug Fisher prepared a plan to mitigate the issue. He advised Councilor Ryan as to the issues, and possible solutions. She said this has been her priority for several years, since Doug's death, to improve the flooding issues.

Councilor Ryan also said the South Onondaga Fire Department was instrumental in aiding her family during health crises. When Councilor Ryan's husband passed, department members were on call to move him from their home to the hospital. She felt it was important to mention that the 21<sup>st</sup> year of his passing is this Saturday, November 8<sup>th</sup>. She said when her mother passed of cancer, the department was called to prepare to move her to the hospital. And finally, the SOFD honored her father, Chuck, with a parade days before his passing. Chief Eric Nelson saluted Chuck, and Chuck returned the salute,

one of his last actions before his death. Chuck's death was on Christmas Eve, and the department once again was at his home. The department honored Chuck with an honor guard at his wake and funeral mass, in addition to an escort of fire trucks to the church. **C**ouncilor Ryan said that the SOFD personnel were wonderful, and she cherishes their friendship. Councilor Ryan's words were met with acknowledgement and agreement from members in attendance at the meeting.

## SCHEDULE "B" AGREEMENT

THIS AGREEMENT, made the 6th day of November, 2025, between the TOWN BOARD of the TOWN OF ONONDAGA, Onondaga County, New York, (hereinafter "the Town") and the \_\_\_\_\_\_VOLUNTEER FIRE DEPARTMENT, INC., a not-for-profit corporation duly organized and existing under the laws of the State of New York (hereinafter "the Fire Department").

### WITNESSETH:

WHEREAS, there has been duly established in the said Town of Onondaga, a fire protection district known as the \_\_\_\_\_\_Fire Protection District (hereinafter "District") embracing territory in said Town, outside of any city or village, as such territory is more fully described in the resolutions duly adopted by the Town Board of said Town establishing or extending said District, and

**WHEREAS**, there is presently in existence between the parties hereto a contract covering the furnishing of fire protection and emergency services to said District as established, and the parties hereto desire to replace said contract with a new contract and provide for a continuation of fire protection and emergency services in said District and for the levying of taxes to pay the cost of same; and

**WHEREAS**, following a public hearing duly called, the Town authorized a contract with the Fire Department for fire protection and emergency services to said District upon the terms and provisions herein set forth; and

WHEREAS, this contract has also been duly authorized by the Fire Department.

**NOW, THEREFORE**, the Town does engage the Fire Department to furnish fire protection and emergency services to said District, and the Fire Department agrees to furnish same in the manner following, to wit:

1. The men, women and equipment of the Fire Department shall, at all times during the period of this Agreement, be subject to call for attendance upon any fires or emergency service in case of accidents, calamities, or other emergencies in connection with which the services of firemen would be required occurring in said District, and when notified by alarm or telephone call from any

person therein of such a fire, emergency, accident or calamity therein, shall respond and attend upon the same without delay with one or more companies and with suitable ladder, pumping and hose apparatus and emergency equipment of the Fire Department. Upon arriving at the scene of the fire, the men and women of the Fire Department attending shall proceed diligently and in every way reasonably required in such fire, emergency, accident or calamity, and the saving of life and property in connection therewith.

- 2. In consideration of furnishing aid and the use of its apparatus as aforesaid, the Fire Department will receive the annual sum of \$\_\_\_\_\_ \_for the services to be rendered pursuant to this contract, which said sum the Town agrees to collect and pay to the Fire Department on or before the 15th day of March in each year that this contract and any renewals thereof is in effect.
- 3. The Town will also pay any and all claims authorized by the New York Volunteer Firefighters' Benefit Law, for medical expenses, loss of wages, compensation benefits or other claims arising by reason of the injury to or death of a fireman, a member of the Fire Department emergency relief squad, or a fire patrol sustained while answering, attending upon or returning from any such call or while engaged in practice or trial runs.

In the event that the Town contracts for insurance indemnifying it against the liability imposed by the preceding sentence of this Agreement, the Town will furnish the Fire Department promptly thereafter with a copy of such policy of insurance or with a written statement to the effect that such insurance protection has been purchased and showing the name of the carrier, the amount of coverage and a general statement of the terms of such policy.

PROVIDED, however, that nothing herein contained shall abrogate the right of the Town to charge back against the property within the said District any of the above charges which may be charged back against such property pursuant to law.

- 4. In accordance with Section 209-z of the New York State General Municipal Law, the Fire Department shall obtain an audit of its records by an independent Certified Public Accountant or an Independent Public Accountant, shall further confirm whether or not it has filed an IRS 990 form and whether or not it was required to file a report regarding foreign fire insurance premium tax funds pursuant to Section 30-a of the New York State General Municipal Law. Required reports and the filed IRS 990 shall be delivered to the Town Clerk within 180 days following the end of the fiscal year.
- 5. This Agreement shall continue in full force and effect for the calendar year 2026, and thereafter, it shall be deemed renewed on the same basis each year for a further term of one (1) full calendar year without any further public hearing unless one of the parties hereto shall notify the other, in writing, on or before the 20th of August that it elects to terminate the contract on December 31 of that year, but, in any event, shall terminate on the 31st day of December following three (3) years from the date thereof. It is further agreed that in the month of July in each year in which a renewal of said contract could occur, the Town Clerk of the Town will notify the Secretary of the Fire Department that the contract shall be deemed renewed on the same basis for a further full term of one (1) year, unless the said Fire Department shall notify the Town in writing, on or before the 20th day of August in that year, that it elects to terminate the contract on December 31 in such year.
- 6. This Agreement may be changed or modified only in the manner in which the original instrument was drafted and adopted.
